Minutes of the Regular Meeting of the Parish Council held on Thursday 25th July 2019 at 7.30pm Mickley Church Room, Mickley.

(**2019 – 029**) **Present** were Cllr Robert Weatherhead (Vice Chairman & Chairman of the meeting), Cllr Ben Robinson, Cllr. Jan Lawson, Cllr. Patricia Harling, Cllr. Sheila Miller and Cllr Brian Thackray.

(2019 – 030) Also present were David Taylor, Clerk, Cllr Margret Atkinson and 1 member of the public.

(2019 – 031) **Apologies** were received from Cllr Topham.

(2019 – 032) No **Declarations of Interest** were received and therefore no **Dispensations** were sought.

(**2019 – 033**) It was **resolved** that the minutes of the meeting held on 30th May 2019, having been circulated for consideration beforehand were true and correct records. The Chairman signed them accordingly.

(2019 - 034) Cllr Margaret Atkinson reported from North Yorkshire County Council that:-

- a. North Yorkshire have bought the Magistrates Court in Northallerton and will be using it from August while the old County Council buildings are refurbished.
- b. Brierley homes (owned by NYCC) are building more homes to make more income for NYCC.
- c. Superfast Broadband is now doing Phase 3 and intend for 95% to be supplied after this is finished the final homes will have to be connected by a wireless network.
- d. The Pension fund is in an excellent state (not like some Councils).
- e. We are working hard on many of the roads and in future going to manage all the work from County Council.

(2019 – 035) Cllr Margaret Atkinson **reported** on the following from Harrogate Borough Council that:-

- a. Council Offices on sale again, Harrogate Borough Council are not out of pocket as a result.
- b. Ripon Pool was approved and work will be starting on ground stability, etc.
- c. This last year 259 affordable homes have been provided of which the Council built 16 and bought 29.
- d. District Plan is still awaited to come back from the Inspector to go out for consultation on the amendments.
- e. The AONB have now done their 5year Management Plan and have asked the Council to let any Planning application of 10 or more come to Committee.

(2019 – 036) The Clerk **reported** that He was experiencing difficulties with IT arrangements at his home office (which is used only for Parish Council work). This had lead to loss of 6 days productivity in recent weeks and he was investigating some sort of IT support package. Council members present felt this was a good idea, particularly when the cost could be split with other Parish Councils.

(2019 – 037) The Parish Council heard from Councillor Miller that the YLCA training day she recently attended was a great success and proved very useful. The trainers at the YLCA were clearly extremely knowledgeable.

(2019 – 038) It was **resolved** to order 8 copies of the NALC publication *The Good Councillors Guide* from YLCA.

(2019 – 039) It was **resolved** that the Clerk should seek out the dates of training opportunities with YLCA and circulate these to Councillors.

(2019 – 040) It was **resolved** that the Clerk should reserve a place on the forthcoming planning training session.

(2019 – 041) It was **resolved** that the Clerk should contact Harrogate Borough Council Planning Enforcement and report the route deviation at the Clayton Farm site in Mickley.

(2019 – 042) It was **resolved** that further investigation should take place in order to gauge the feeling of Mickley Village residents of what steps should be taken to control traffic speed through the village. – **Clir Harling to lead**.

(2019 – 043) The Parish Council heard that a tree survey had been carried out in the relatively recent past. Cllr Lawson said that she would locate the relevant documents and forward them to the Clerk in order that further action can be considered.

(**2019 – 044**) The Parish Council heard that the proposed changes to speed limits in Galphay village are now as acceptable to village residents as they ever will be.

(2019 – 045) The following Correspondence was considered:

- a. Poppy Appeal co-ordinator required for Galphay Cllrs Weatherhead and Robinson will ask around Galphay residents to see if there is some prepared to take this duty on.
- Re: Road repair in Azerley Parish Council area The Clerk is to reply to the letter received from Richard Flinton of NYCC regarding road repairs in Mickley and Galphay.
