To receive and approve apologies for absence

Apologies for absence had been received from Cllr Ross.

PC Picton introduced himself to the meeting. He is the beat officer for Mersham. Fly tipping and Rural crime is an issue in the village. There is £8400 unspent for spiking kits, applications can be obtained for the local public houses.

- PB spoke to Linda Harman last Monday. Aldington and Bonnington PC have decided to go ahead with a Judicial Review. They are considering, Mersham PC could contribute. PCs are not expected to meet more than ½ of a JR. However, if this goes through the first stage, only 25% of these are accepted, the costs are £55,000. There is seed-funding available from CPRE.
- There is a hearing date for the IBF, this is 2nd December at 10am. PB is attending and is a registered party. Planning Inspector knows what PB intends to say. Lighting, noise, litter etc.
- EScooter rider getting to work at the IBF has now ceased travelling on the A2070 to get to work.
- New app for walking safe in the dark is to be launched on 25th November.

Any idea how long tankers will be travelling up and down Kingsford Street? This will be completed by Christmas. Kent Highways have explained the permit runs until January. The size and number of vehicles in Kingsford Street is not appropriate. The emergency access route could logistically be used through the IBF, this is inappropriate impact in Mersham. The IBF could relieve the pressure on the village of Mersham. There are no passing places for vehicles this size. TB to contact Kent Highways and CC in ClIr Collins.

Vehicular access to Finberry extension is likely to be announced in Summer '26 as part of the call for sites.

The PC has attended the IBF introductory meeting. PCs met with planning team and provided a good input from PCs. Lighting has been updated and additional measures have been put in place. We would like to feedback on the lighting.

The aesthetics problems do not appear to be met. Many hedges have been removed and seems stark. They are talking about Landscape Management Plan.

Hoping to get Mersham included in the noise assessment plan.

They have indicated that they will carry out an Environmental Impact survey as trees in the area are dying.

GM has circulated the lighting amendments that have been made and went through these for the IBF. The buildings are lit and we look to them turning these off. GM wants to report back on whether there is an improvement in the lighting. The High Field is to be protected for 30-year period whilst the IBF is in place.
