4. Matters Arising from 3rd February 2015

a) Footpaths and stiles:

Pat received a request from a villager about the possibility of having a kissing gate installed along a part of the Greensand way footpath as it was difficult to get their dog over the stile. Pat explained that it is not the responsibility of KCC to provide a kissing gate for this reason. The ramblers association is to follow up the request.

Pat noted that the footpath at Appleberry Farm is not accessible to walkers and is to follow up.

A letter of complaint has been received about the residents at Green Wicket Animal sanctuary when the villagers were trying to access the footpath. Pat will contact Green Wicket and set up a meeting with the residents and another Cllr.

Peter Rawlinson and Richard Wall are still working on the mapping of drains within the village, they are awaiting maps to compare from KCC.

It has been reported that the works on the potholes in Newland Green road had been completed. This is not the case as only a few have been done. Another inspection was carried out and more works were undertaken. The problem still has not been resolved fully. Pat will check on progress.

Coach road to Burnt Mill road there has been some fly tipping. Pat has reported.

There has been another accident on the bend along Forstal Road near to Brook Gate caravans, the Clerk is to contact Highways to request some signage/chevrons be placed along the roadside.

d) **Strong box:** The Clerk has found a cabinet that is fireproof the price is in the region of £1200 including VAT this would be fire resistant for 30 minutes. Following discussions it was decided that the archive should be checked to see how much paperwork would be needed to be stored and what size

cabinet may be needed. Lois Tilden has offered to undertake the work with the help of one or two other people.

Bill found out that the company Keith was to use for the glass recycling was Berryman glass, Berryman glass would provide banks for glass but revenue would need to go through KCC or ABC and then to a charity.

Bill and the Clerk had a meeting with Charlie Simkins but he couldn't help much as he was to go on holiday the next day. The Clerk then contacted Sam Robinson at ABC who previously sent out recycling credits. Sam informed the Clerk that ABC have nothing to do with the recycling or monies any more. The Clerk then tried various different companies but the outcome was similar that the price paid for recycled products has dropped.

If anyone has any ideas or knows of a company who could help please let the Clerk know.

Object: Unanimous

Egerton Parish Council wishes to object to this application. EPC believes that the original case (10/01576/AS) for permitting the agricultural buildings on this site was based on a reasonable **agricultural need** as set out by the landowner. It follows that an extension of one of the buildings on this site and its change of use to a holiday let would be completely inappropriate for the following reasons:

• In 2010, planning permission was granted retrospectively for the erection of two general purpose agricultural buildings. The planning permission was, however, granted subject to several stringent conditions, including: "Should the agricultural use of the buildings within the unit permanently cease within ten years from the date of this permission, then, unless the Local Planning Authority have otherwise agreed in writing, the buildings shall be removed from the land and the land shall, so far as is practicable, be restored to its condition before the development took place, or to such condition as may have been agreed in writing between the Local Planning Authority and the owner of the site. Reason: In the interests of protecting the character and appearance of the countryside. The buildings hereby approved shall only be used in connection with the agricultural use of the land identified within the blue

line on the approved site location plan. Reason: Planning permission is only granted due to the established agricultural need and to allow the Local Planning Authority to review the appropriateness of other uses in this location." EPC understands that the original planning consent from ABC (10/01576/AS) was only granted only on the assumption that there was a reasonable agricultural need as set out by the landowner. Therefore there is no justifiable reason to rescind the conditions and allow a change of use nor to extend the building for any reason. If, as the applicant states, the office section of the building is now surplus to requirements, then it should be removed, as the building was approved only as a result of 'an established agricultural need' and only to be used in connection with the agricultural use of the land comprising the whole of the orchard site, and the land on which it stands should be restored to its previous condition according to the terms of the original planning consent.

- The site contains a scheduled ancient monument Bowl Barrow (Bronze Age Tumulus) (TRS18)
- The site is adjacent to the Egerton Conservation Area and beyond the built confines of the village it would have been included, but was an open field without buildings before the agricultural buildings were erected (TRS, para 7.6)
- Development in the open countryside for non-agricultural reasons should only be permitted in very exceptional cases such as wholly substantiated local needs housing (GP 12, TRS Para 4.4)
- This is not a case that could lead to the preservation of an historic barn or long-standing agricultural building that may have become redundant the building is under 5 years old and is not part of Egerton's heritage (TRS12 &13, not over-ridden by the Government's NPPF nor the Permitted Development Order 2014)
- The site is within a Special Landscape Area the Egerton Greensand Fruit Belt. In line with the National Planning Policy Framework to protect and enhancing valued landscapes, change of use to non-agricultural purposes would fail to protect the Special Landscape Area (TRS 17)
- It does not constitute sustainable development (para 11, NPPF)
- Indiscriminate intensification of development in the countryside is detrimental to the countryside in its own right and should be ruled out. (para 6.7, Core Strategy)
