

THE DISTRICT OF ROTHER (TEMPORARY ROAD CLOSURE) (VARIOUS STREETS, BATTLE) NO. 1 ORDER 2016

The Council of the District of Rother, in exercise of its powers under Section 21 of the Town Police Clauses Act 1847, as amended by Section 28 of the East Sussex Act 1981 and of all other enabling powers, and after consultation with, or with the consent of, as may be required by statute, the County Council of East Sussex and the Chief Officer of Police, hereby make the following order:-

- 1. For the purposes of facilitating the holding of the Battle Carnival procession organised by Battle Bonfire Boyes the lengths of roads set out in the First Schedule to this Order and more particularly shown by a thick black line on the plan attached to this Order, shall be closed to vehicular traffic between the hours of 11.00 a.m. and 12.30 p.m. on Saturday, 25 June 2016 as provided by the above mentioned provisions subject to the terms and other conditions set out in the Second Schedule to this Order.
- 2. Nothing in this Order shall prevent a Police Officer from suspending for any period the provisions of this Order in respect of any highway closed by virtue of this Order or prohibit any act done at the discretion or with the consent of a Police Officer.
- 3. Should, in the opinion of the organisers of the procession for which the highway is to be closed to vehicular traffic under the provisions of this Order, it be no longer necessary for the highway to be closed, or should the event be cancelled, then the provisions of this Order shall be suspended for the whole or part of the period for which the closure is provided for.
- 4. The making of this Order does not authorise or otherwise make lawful the obstruction of the highway nor shall it be interpreted as giving such authorisation.
- 5. This Order may be cited as "The District of Rother (Temporary Road Closure) (Various Streets, Battle) No. 1 Order 2016".
- 6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament, as if this Order were an Act of Parliament.

FIRST SCHEDULE

Details of Roads and Lengths of Roads in Battle to be affected by the Order

North Trade Road (from Chain Lane to the roundabout with High Street), High Street and Abbey Green .

SECOND SCHEDULE

- 1. The organisers shall be responsible for any injury or damage to property or persons caused as a direct result of the activities and the organisers should ensure that they obtain satisfactory indemnity insurance cover.
- 2. Signs and barriers shall be erected in accordance with the Traffic Signs Regulations 2002 Act and in accordance with the Traffic Sign Manual, Chapter 8.
- 3. The organisers and any stewards on duty on the day of the event must observe any directions which may be given by a uniformed police officer, fire officer or ambulance officer.
- 4. Stewards shall be provided at all road junctions within the Town of Battle until such time as the roads concerned are once again open to vehicular traffic.
- 5. All official stewards shall be issued with a badge or armband to indicate that they have been appointed as a steward so as to ensure that they are easily recognisable by the Police and emergency services.
- 6. The organisers shall be responsible for clearing the street of refuse after the event has been held.
- 7. One month before the event a Schedule of Marshals will be provided to the Police together with contact numbers on the day.
