77 WELCOME AND APOLOGIES

No apologies received.

78 PUBLIC SESSION No issues raised other than covered on the Agenda.

79 MINUTES OF PREVIOUS MEETING of 29 September, agreed and signed.

80 DECLARATIONS OF INTEREST in items on the Agenda, none.

81 REPORTS TO MEETING

.1 Hart District Councillor Anne Crampton, report and discussion

i Local Government Reorganisation – Majority proposal to Government at **APPENDIX I**.

Hart has submitted its agreed preferred Option for Unitary Councils across Hampshire – Option 1A – to Government for deadline of 26 September. This is in agreement with the majority of other first and second tier councils in Hampshire. 'Option 1' is a proposal for four mainland unitaries – with various configurations for the southern councils considered along the way – but always including a North Hampshire Unitary comprising BDBC, Hart and Rushmoor. The joint proposal is entitled: *Close enough to be local, big enough to stay strong*. Government will consult later this year.

The proposed Northern Unitary has no current centre for 'County' responsibilities but a director of social services and adult social care has been appointed.

ii Local Plan update Progress is very behind, the delay much to do with lack of resources, more planners are being recruited. The proposed timetable (Local Development Scheme) **APPENDIX I** says submission by March 2028 just before the end of the life of Hart Council. Examination will go beyond that, adoption shown as October 2028.

iii Cost of living support grant total £50K – for grants up to 5K to help people in hardship, poverty – remains open to 07 November. Applications should be from local agencies who provide help and support to individuals and families in need; eg foodbanks / food clubs / food pantries; community projects supporting vulnerable residents; organisations promoting cookery skills on a budget; family support / care organisations. Examples of projects might be – cookery classes; self-help skills projects; money management / budgeting courses; winter school holiday programmes; health and wellbeing initiatives.

iv Question re what happens to existing Hart Council buildings? Council buildings are capital assets not allowed to be sold. Have been looking at where the new council offices would be. Part of the current Hart building is used by Farnborough Tech and they wish to stay; renting out the buildings is a good source of income.

.2 County Councillor Tim Davies report and discussion

i Local Government Reorganisation (LGR) Everyone is aware that County, along with East Hants, submitted their own proposals for three mainland unitaries, based on a Greater Portsmouth, a Greater Southampton and the rest of Hants based in Winchester.

ii Discussion One reason Labour may favour a Northern Unitary is that it gives them some prospect of controlling the Council – LGR is very much about control; will only get money if do what Government wants – No matter what is submitted, will go ahead as Government wishes – But the money not there – To bear in mind Government is short of funds and this process not fully costed, potential for them to decide all too costly – Government has just rejected the idea of the Isle of Wight remaining a single unitary.

iii Some good news that the last Full Council meeting approved a new (though reduced)

County Councillor devolved budget for 2025/26, despite it not being a statutory requirement. The budget has been cut further from 8K to 5K; likely safe from further cuts now until the end of the life of the Council.

iv County elections will go ahead next May, along with District and Mayoral elections for the Combined County Authority. For County and newly-elected District Councillors, the term will be only be for two years.

82 DEFIBRILLATORS

.1 **Registration** Hound Green – Registered guardian ST; Leather Bottle – ST to register; The Mutton – Pub is registered guardian.

.2 **Regular checks** (ideally every week) to ascertain all is well; the defibs self-test daily the green tick should be showing in the corner box. Hound Green – Resident checks in place, backup KA. Leather Bottle – checking by GC. Reporting is to ST for logging on Circuit and recording in minutes. Current situation, both checked and operational. The Mutton – Pub is registered guardian and undertakes its own checks.

.3 **Training** South Central Ambulance to confirm date for training at the Leather Bottle; agreed Parish Council will cover suggested donation of £10 per person.

83 HOUND GREEN

.1 **Pond project:** Recent meeting, ST with Hart's Flood Risk Management officer at Hart offices; Hart officer is proposing a site visit and to provide local mapping for the area. The 1915 OS map showing the original location of the pond, and the Ecologist's initial report from the site visit April this year, have been forwarded to him.

.2 **Christmas tree and carols on the Green** KA to discuss tree with Hortus. Resident is pursuing potential for local choir support. To set a date for carols.

.3 **Bus shelter maintenance** KA to approach Merronbrook. AP is regularly checking on the shelter in passing.

i. New applications since last meeting
25/01916/CA (Validated 06 Oct) Bannisters Farmhouse, Mattingley Green. T1 Oak – deadwood. T2 - Wild cherry - Crown reduce by 5m and crown lift to 3.5 m from ground level. Parish Council no objection, no comment.
24/00428/HRA (Validated 03 Oct) Priors Farm, Reading Road. Application under Regulation 77 of the Conservation of Habitats and Species Regulations 2017 pursuant to 24/00428/GPDAGD. Application for notification for prior approval for the change of use from use as agricultural buildings to use falling within Class C3 (dwellinghouses). Parish Council content to leave to discretion of Case Officer.

ii. Ongoing applications of note
25/00477/FUL (Validated 21 March) The Mutton at Hazeley Heath. Erection of eight units of guest accommodation with associated parking, landscaping and new sewage treatment plant. New documents on website 30 September: Parking plan, and signed agreement with farmer to park staff cars at the farm. Noting the latter can be terminated at any time. Also covering letter from Agent which says:
' It can be demonstrated that additional parking (eight spaces) can be provided within the scrub/overgrown area in the SW corner of the site that could be designated solely for the guest accommodation, hence more than adequate provision can easily be made.'

Discussion – problems caused by parking continues – the farmer unable to get milk tanker in and out – neighbours continue to be blocked in or out – drivers often rude if asked to move. However is better than it was, and the provision for eight extra spaces welcomed. Parish Council agreed it will no longer object if addition parking is provided.
