- Cllr Jopling asked the Council to consider purchasing new 30mph bin stickers for the village. He had noted many were fading and that many residents now had the new brown garden waste bins. It was agreed that the signs had been successful and Cllr Jopling could investigate the purchase of new stickers.
- Concern was expressed as to the future of the Blue Bell Inn. It was noted that the pub was available to lease and that the marquee had been dismantled.
- The dates for the first round of judging in the BKVC are 4th-22nd June and the second 2nd-20th July. The Council ask all residents to keep their frontages neat and tidy to show the village at its best.
