# Successful CIL bid to improve School Traffic Safety

Stockbridge Parish Council is delighted to confirm that the Council's application for the CIL funding from TVBC, for the last outstanding traffic safety measure around the Primary School, has been successful. This safety measure, to make Old London Rd one way, going from the White Hart roundabout to the A30, is intended to make the narrow residential road a safer environment for residents, parents and school children. It compliments the safety measures already agreed by HCC; to provide brighter clad-



ding on the bollards, school flashing signs, refurbishing road markings and measures to reduce the approach lane to the A30 to a single lane.

The one-way street is set to improve parking for parents at the Primary School because it will ensure that all vehicles will drive into the road and park in one direction, this will ensure a safer drop-off and pick-up for children and parents. Old London Rd residents have also had to put up with fast moving traffic using the road as a cut through to avoid the two roundabouts, when following a slow lorry down the A30. This can be especially dangerous at school pick-up time.

This is a very exciting development which will make a real improvement for the residents of Old London Rd and the parents and children of Stockbridge Primary School. The Council would like to thank Cllrs Iain Bell and Guy Boney for working with the community to lead the project and the Clerk for completing the successful CIL bid with Cllr Bell.

CIL is community infrastructure Levy which is payment by developers to contribute to infrastructure costs.

# What is the Council doing about parking on the High Street?

In May 2020 the Council's Traffic Parking Working Party decided to poll all high street residents and traders, between White Hart and Longstock cross-roads, to understand their views on parking. This feedback would be used to inform any proposal by Hants County Council (HCC) to impose parking restrictions/ charges on the village. The majority of the respondents against parking strictions being imposed. Their replies also contained comments that (1) parking spaces should be marked on the high street to ensure maximum use of the available space; (2) the use of parking spaces for commercial purposes by residents should bе banned/ discouraged; (3) all daytime/ parking overnight by "dormitory parkers" should be banned; (4) more use should be made by employees of traders of the 32 extra parking spaces between the two A30 roundabouts.

The Traffic Parking WP drew up detailed plans embodying all these comments, which were approved by the Rt Hon Caroline Nokes MP at a Zoom meeting (this meeting included

Gerald Dodson, Chair of the SBA). She agreed to put SPC in touch with the relevant personnel in HCC.

Further progress on this project has had to be put on hold due to the Covid pandemic and the necessity to make high streets a safe environment. HCC worked with the Council to decide the positioning and types of the barriers that were required so that the best solution for the community was put in place. HCC have since praised the Stockbridge layout and have been promoting it throughout the borough as an example of what works and what does not.

This was followed by a meeting in Sept 2020 between Cllrs and HCC Highways. HCC agreed to draw up a design for the High Street to be put to the Council and the community for consideration.

At present the project is moving slowly because of Covid uncertainties. However, the Council are considering instructing a third party consultant to advise on the wider aspects which may go beyond parking, e.g. safety, speeding. It is work in progress and the Council awaits the suggested HCC design.

### Helen Jackson - Our New Councillor

Cllr Helen Jackson was co-opted end of January. Helen explains "I first started coming to Stockbridge in the 1980s to shop and admire the wonderful antique shops. Subsequently, I acquired Squirrels and created the tea rooms on the first floor. After a house move and massive renovation project, I relinquished the business but in 1998 my daughter opened The Owl and The Pussycat, and shortly after this I moved into Stockbridge

permanently. I worked full time at The Owl and enjoyed many years of meeting residents and visitors alike. My daughter has now sold the shop on and I am now learning to enjoy retirement"

She adds "over the years the parking controversy hasn't changed much! but I hope I can serve the people of Stockbridge well as a member of the Parish Council."

# Keeping the High Street Clean



Few residents of Stockbridge would disagree that last year brought an increase in the volumne of visitors to Stockbridge. Sadly this has meant an increase in littering on the High Street. Mindful of the inadequate and outdated drains in the High Street, which only have 10% spare capacity and which would be in danger of blocking with the excess rubbish, Cllr Bell has been working with TVBC to organise sweeping each the side of the High Street on a weekly basis.

The first deep clean went very well and the Council and TVBC were very grateful to all members of the community who moved their vehicles on the evening of Sunday 21st February and Monday 22nd February in order to allow the gutter cleaning machines access to the side of the road. However,

after this initial successful clean, Stockbridge Parish Council and TVBC took the decision that the appropriate course of action would be to reduce the number of times that the gutter cleaning machine is used on the High Street. It was agreed that the machine would be used every other week and in the interim period the gutters would be manually swept. This is to make allowances for members of the community who expressed disquiet at having to move their cars too many times.

The Council will be approaching the coffee vendors to persuade them to encourage their patrons to bring their own re-usable cups, as we move out of Covid.

# **Election Time**

May 6<sup>th</sup> is election day. Elections will be for the Hampshire Police and Crime Commissioner and for the local Hampshire County Council Councillor (Cllr Gibson will not be standing at this election). It is also possible that a by-election will be held for a new Councillor for Stockbridge Parish Council.

As usual the Stockbridge polling station will be at the Town Hall but there will be a range of adjustments to ensure the polling station is kept Covid secure such as one way systems, floor markings, hand sanitiser sta-

tions at the entrance and the wearing of face coverings. Voters will be asked to keep socially distanced and it would be preferred if voters bring their own pencils.

The deadline for applying for postal votes is 20<sup>th</sup> April and for applying for proxy vote is 27<sup>th</sup> April.
