T Simmons said the Local Development Plan Consultation period is due to commence in June/July. There are to be three open days on Market Hill and presentations to town and parish councils. Town and Parishes are to be consulted by the District Council on how council tax monies are to be spent. Cllr. R Silvester said at the last Suffolk County Council meeting the Brandon Relief Road scheme was mentioned.

Members of the public raised matters relating to the lack of advertising for the Annual Town meeting; the flint plaques at the community centre; the nine stiles currently being stored at Ford Farm; Doodles Pond; a storage unit at the allotment site (an agenda item); town bus; A11 signage at Munford Roundabout; fencing and threshold at the south east corner of Victoria Avenue; the level crossing barriers at Brandon station.
