23-167 To receive apologies from members of council and accept valid reasons for absence Apologies for absence received from Cllr. Mooney.

23-168 Declarations of interest

- a. To receive members' declarations of interest in accordance with the adopted Code of Conduct and Standing Orders: Cllr. Smith declared an interest in any matters relating to the allotments, Joint Burial Committee and pre-school. Cllr. Kavanagh declared an interest in any matters relating to the Playing Fields Association and the Village Hall Committee.
- b. To receive and consider members' requests for dispensations in accordance with the adopted Code of Conduct and Standing Orders: No requests for dispensations received.

23-169 To receive an update on the ordinary vacancy and consider co-option No update to report.

23-170 To adjourn the meeting for contributions from other representatives and members of the public

- Residents asked for an update regarding the uncut grass verge at Fairway Meadows. The Parish Council
 advised that Harborough District Council and Leicestershire County Council have both confirmed that the land
 is not their responsibility. The Parish Council have contacted the developers, Bloor Homes, to find out what
 the arrangements are for the maintenance of the land, no response has been received. There is no registration
 for the strip at the Land Registry. The Parish Council will continue to try and get a response from Bloor Homes.
- Residents asked for an update on the rubbish being dumped outside a property on Fairway Meadows. The
 Parish Council advised that the Platform Housing Group have confirmed that they are responsible for the
 property and will arrange for the rubbish to be removed. The residents advised that further rubbish has been
 dumped since the original report.
- Residents asked for an update on the two streetlights that are on all the time. The Parish Council has reported
 the one on Main Street to Leicestershire County Council and the one on Fairway Meadows to Balfour Beatty
 who it belongs to.
- Residents asked for an update on the parking issues at the school. The Parish Council advised that the school
 have sent out two communications to parents and carers in recent days asking them to park considerately and
 carefully.
- A resident raised concerns regarding persistent speeding through the village. The Parish Council will contact
 Leicestershire County Council to ask them to assess options that may be available. The Parish Council will also
 investigate the Speed Watch Scheme. The Parish Council will also contact the local police to see if there is
 anything they can do to help.
- Clare Robertson Smith from the Village Hall Committee advised that the Committee have been successful in obtaining s106 funding and planning permission for the improvements to the village hall. The Parish Council congratulated the committee on their achievements.
