# C/137/19 To receive reports from District and County Councillors.

Bucks County Councillor Anne Wight gave her report which included two consultations for the new Buckinghamshire Council.

AYLESBURY VALE DISTRICT COUNCIL District Councillor Chris Poll gave his report which included a reminder for residents to register to Vote. There are Woodlands Trust grants available and advice on offer. Cllr Poll will be taking part in an abseil for charity on the 21<sup>st</sup> September for Nest Aylesbury Vale.

# C/138/19 To approve the minutes of the previous meeting.

# C/139/19 Planning Applications:

19/02871/APP – Brookside, Ford End, Ivinghoe, Bucks LU7 9EA. Change of Use residential land to a builder's yard (B8) (retrospective).

IPC will comment this is outside of the settlement boundary of lvinghoe and Ford End and therefore does not meet with policy HSG2 within the NDP. PROPOSED BY Cllr Lott and SECONDED BY Cllr Bamber and carried unanimously.

It was agreed that R Landers will trim the hedge at the allotments back to previous cuts, area to be left tidy and lvinghoe Lawn Horse Chestnut stump ground out so area can be mowed £320. PROPSOED BY Cllr Groom and SECONDED BY Cllr Lott and carried unanimously.

The lvinghoe Lawn play area has been very busy over the summer months. There has been an increase in parking problems around the Lawn which will be mentioned to the Bucks CC LAT.

The bridleway is very overgrown and problematic with flytipping being dumped there often which an Ivinghoe Aston resident is regularly removing. Bucks County Councillor Wight will follow up with Bucks CC.

Cllr Lott reported the parish LED streetlight installation project is due to start within the next few weeks.

Speedwatch – the yellow Community Speedwatch signage is in place through the villages and already there has been a decrease in traffic speeds through lvinghoe. Cllr Lott encouraged residents to get involved in Speedwatch.
