The first step would seem to be testing of the river water to determine the level of pollution. Dorset Council Environmental Health did some testing a couple of months ago at the Seatown end and found that there are significant levels of bacteria. This was following the August storms when effluent was discharged into the Winniford from the outlet at Seatown. However, they are more used to testing drinking water! The project would cover the whole of the river, as there are farms upstream and many properties in North Chideock with septic tanks. An additional factor is the lagoon which forms at the mouth of the river at Seatown, where shingle holds back the water. Many children and dogs play in this and there are concerns that contaminated water will cause illness. There have been several instances reported, by word of mouth, where local dogs and humans have been unwell. There is no way of knowing how many of the many people (and dogs) who visit this beach, both for the day and while staying at places such as Golden Cap Holiday Park, are subsequently unwell. Dorset Council is currently preparing a suitable warning sign, but we all know that many people don't read signs. So, why am I contacting you? It's because Michele Warrington of Loders Parish Council told me that you are helping their group. So please will you help Chideock? Though no Community Group has been formed as yet, there are 4 people interested, at least 2 of whom are happy to do water sampling if the necessary equipment is available,"

However, this does not appear to be the issue here and such powers do not extend to requesting landowners increase the capacity of ditches/ordinary watercourses. The Environment Agency risk of surface water flooding maps indicate that there is prevailing 'medium' risk of flooding in Sea Hill Lane, and as Blair has advised residents should be encouraged to report flooding to property or the area on the 'FORT' (previously SWIM) flood reporting tool on the Dorset Council website.
