a) Ditch investigations

The Clerk reported she had contacted Mrs Jean Day concerning the newts. These are in her garden pond and as they do not like flowing water Mrs Day does not believe they will be a problem for the proposed drainage works. They have survived two 'diggings out' before. The Conservation people have been to inspect and she has heard nothing further from them. Cllr Allen added that he had heard traps were going to be set to catch the newts.

b) South Beck Lane

The Clerk advised she had received a letter from Nottinghamshire County Council's Mr Birt dated 27th March 2003 advising the pipe under the lane was due to be 'jetted' and cleaned within the next 2/3 weeks. It was confirmed that this had now taken place.

a) Fernleigh, Church Lane, East Drayton. The Council noted that permission had been granted. However, the amended plans had not been resubmitted to the Parish Council for their consideration. It was AGREED Cllr Shreeve contact the Planning Department to inspect these at the Retford Office and report back to the Clerk.

9 Lytchgate

i) Cllr Jones advised the lytchgate was on schedule for the end of May. Kirk & Bills are currently morticing the joints and will make contact when they start erecting it in

- their yard.
- ii) Cllr Allen advised he had an OS 1:5,000 plan of the village (showing all 95 properties) and had put together a comprehensive village survey for inclusion in the capsule. The Chairman thanked Cllr Allen for his work on the project. Various other suggestions for possible inclusion are: photo/details of an orchard planted up in 1993, Mrs Goddard's corn dolly, still awaiting Dunham school children's input, old photograph of Horbling c1900, Hawksmoor photograph, any photograph depicting past farm life, aerial photographs, coinage, newspapers, minutes of when it was first decided to have a new lytchgate, first day cover stamps and a CD. It was AGREED to have a deadline of Friday, 2nd May for anyone who had anything for the capsule, to meet in the village hall at 2.00 pm. (A list to be made of what has gone in for Parish Council records).
- iii) Cllr Parker suggested ringing the Retford Times to let them know when the lytchgate would be in situ. The Chairman added that the Countryside Agency had asked for any publicity the project received is sent to them.
- iv) The sandblasting of the finial has not yet been organised. Cllrs Small and Jones are looking into this.

Discussion followed concerning replacement of the present notice board. The spare metal-framed notice board was deemed too small and Cllr Jones suggested a lock be placed on one side of the village notice board as several flyers had been placed over Parish Council papers. This was AGREED and the Chairman thanked Mr Hardy for his kind offer.
