

Meeting of Rockland St Mary with Hellington Parish Council held on Tuesday 10th November 2020 This meeting was conducted using the Zoom online facility

Public Participation Session

There was no public participation at this stage of the meeting.

County Councillor's Report

County Councillor Barry Stone outlined his recent report on Digital Connectivity, a Government initiative which called on local councils to help ensure people can access better broadband and mobile connectivity. The Clerk had circulated this to all Councillors.

Councillor Stone reported that he had looked into vehicular restrictions for School Lane and confirmed that, apart from the cul-de-sac sign that was already in place, there was no other appropriate nationally-approved signage for this road.

District Councillor's Report

District Councillor Vic Thomson had submitted his report which the Clerk had circulated to all Councillors. He first spoke of Government grants that were being made available for those who had had to close premises due to the lockdown, and noted that grants for the self-employed were to be available soon.

Councillor Thomson mentioned the South Norfolk Council Help Hub, available seven days per week, which offers services and support via a "Community Connector" who covers the local area. He also spoke of funds being made available to Norfolk County Council which they have placed within the Norfolk Assistance Scheme, to assist with a number of initiatives including the provision of food for people who are facing difficulties. Ward grant money is still available, and Councillor Thomson urged any eligible community group that might benefit from this to contact him as soon as possible.

Those eligible for the flu vaccine were reminded to have it as soon as possible. Information on eligibility for the free flu vaccine can be found using the link below and also via the Parish Council website.

Finally, Councillor Thomson reiterated the need to stay safe and protect one another during these times. Despite being in an area reporting a relatively low number of Covid cases, the need remains to follow guidelines in order to prevent the spread. MINUTES

Present: Cllrs Kate Bevington (Chair), Catherine McCormick, Nikki Green, Paul Francis, Mike Hayward, Ernie Green and Jo Norris. Vanessa Sewell attended as Clerk. There was no attendance from members of the public.

18.036 Apologies for absence

There were no apologies for absence.

NOTED.

18.037 Declarations of interest

There were no declarations of interest.

NOTED.

18.038 Minutes

Minutes of the meeting held on 14th October 2020, copies of which had been circulated to all Councillors, were agreed and will be signed as a correct record by the Chair.

18.039 Matters Arising

18.039.1 Rockland Wildfowlers Association Lease – the surveyor from Savills would meet with Councillor Bevington and Seb Shelton of the Poors Trust on 12th November for a site visit. **NOTED.**

18.039.2 Resiting of panel of fencing at Green Lane – Councillor Hayward reported that this work had been completed.

NOTED.

18.039.3 Verge on The Street opposite Post Office – Gary Overland of the Highways Department had confirmed that improvement work would go ahead at no cost to the Parish Council. A short section of the existing slabs would need to be re-laid to adjust the levels. It was hoped that this work would be carried out in the coming weeks. *It was agreed that the Clerk would contact the owner of the affected property to request confirmation that they are happy for this work to go ahead.*

AGREED AND NOTED.

18.039.4 Bus shelter application – Gary Overland had confirmed that Highways had no objection to the installation of a bus shelter on The Street; however there seemed to be a discrepancy as to where Mr Overland thought the bus shelter would be sited. It was agreed that the Clerk would request a site meeting with Mr Overland and Councillors Green and Hayward, to confirm the location.

AGREED AND NOTED.

18.039.5 Installation of gateway signs on The Street – these had been ordered but further delays had been experienced due to staff shortages. It was hoped that they would be installed early in the New Year.

18.039.6 Sign from Hellington entering Rockland – the contractor, Norse, had apologised for the delay in ordering the sign but it was hoped that it would be in place before Christmas. **NOTED.**

18.039.7 New Inn Hill "Slow" signs on road – Gary Overland reported that it was hoped these would be in place before Christmas.

NOTED.

18.039.8 Salt for salt bin in Hellington – Councillor Francis confirmed that this had been filled. **NOTED.**

18.039.9 SAM 2 post near Broadfield Way – it was agreed that the Clerk would send a photograph of the damaged post to Gary Overland and request that Highways arrange for it to be replaced.

18.039.10 Dog fouling notices – District Councillor Thomson had indicated that additional signage could be funded using his Ward Grant if it is purchased by an eligible group other than the Parish Council. The Clerk had enquired of the Parish Room Committee as to their willingness to purchase the signs on behalf of the Parish Council, upon which they would receive a refund from the Ward Grant. *The Clerk would await a response from the Parish Room Committee.* **AGREED AND NOTED.**

18.039.11 Parish Council website review – it was agreed that the Clerk would continue to streamline and update the website content.

18.039.12 Separation of accounts for Council and CIL money – the Clerk had provided Councillors with a spreadsheet showing the current balance of accounts for Council, CIL and S106 money. *It was agreed that the Clerk would provide this information to Councillors prior to each Parish Council meeting.*

18.039.13 Staithe Car Park pothole repairs – Councillor Hayward noted that the big increase in visitors to the Staithe had had a significant impact on the condition of the car park. It was agreed that the car park should be closed for a day to enable repairs to be carried out. **Councillor Hayward would liaise with the Village Caretaker to identify a suitable date for repairs and would install signage to advise visitors of the closure.**

18.039.14 Updated asset register – Councillors E Green and Hayward would provide the Clerk with a list of playground items that had been removed. *The Clerk would update the asset register.*

AGREED AND NOTED.

18.039.15 Climate Emergency group – members of the group had responded to the Clerk's request that Councillor McCormick is kept up-to-date with the group's meetings and any other information. Councillor McCormick looked forward to being invited to the group's next meeting, and to reporting back to the Parish Council on matters discussed. It was further discussed that the Parish Council website could feature a page showing links to recycling information and initiatives. *It was agreed that Councillor McCormick would put this together and send to the Clerk for publication.*

18.039.16 Installation of bench at Hellington – due to inclement weather this had not yet been installed. *Councillor Francis intended to carry out the work as soon as possible.*

18.039.17 School Lane safety issues – Councillor E Green had contacted Norfolk Police to enquire about the availability of a School's Allocated Police Officer to assist with the problem of parents parking inappropriately or driving too fast along School Lane. *He would report back at the next meeting if a response had been received.*

18.044 Use of abandoned boat for village flower display

The Clerk would contact District Councillor Thomson for advice on how to dispose of the boat.

The Chair requested that the proposed Public Space Protection order from South Norfolk Council regarding dog fouling is published on the Parish Council website. *The Clerk would publish the document on the website.*

18.046 Reports from Councillors on their areas of responsibility

18.046.1 Black Horse Dyke Car Park - Councillor Hayward reported that the "No Overnight Parking" signs had been installed.

NOTED.

18.046.2 Footpath report – Councillor Bevington had nothing to report.

18.046.3 Rockland St. Mary School – Councillor E Green reported that the school continued to perform very well, with no immediate problems. **NOTED.**

18.046.4 Green Lane Playing Field - the playing field had successfully re-opened in time for halfterm, and the Council had received a good deal of positive feedback on the new equipment. Councillor N Green reported that, unfortunately, some of the plastic bird-deterrent spikes had already been deliberately broken off the top of one set of swings. In addition, the tyres concreted into the ground would need to be removed as soon as possible as they contained exposed metal. She had consulted EPS, who had carried out most of the recent work at the playing field, on the most effective way to remove the tyres. EPS had offered to grind the metal to the ground, cover with soil and remove the 47 tyres for a very reasonable price of £515+VAT. Given the urgency of this matter and the efficiency and professionalism EPS had shown throughout this project, the Chair proposed that the Council should commission EPS to carry out the work. This was seconded by Councillor E Green. Councillor N Green would also ask EPS to remove two additional fly-tipped tyres as part of their quote. Councillor N Green further reported that she had explored alternative options to create a barrier to stop people driving onto the field. An option was to create a mound over the sleepers in the car park. Where the slide had been removed it was suggested that the slope be planted with trees. It was agreed that the Clerk would contact District Councillor Vic Thomson to ask about available "green" grants, and also consult the Tree Warden, Michael Brett. Wheatfen in Surlingham might provide some saplings for this purpose, and Councillor McCormick would contact them to ask if this was possible. She would also speak to the Climate Emergency group about this project once the amount of funding available had been ascertained. Finally, Councillor N Green reported that she had found some rot below ground level on one of the legs of the baby swing, which she would monitor. AGREED AND NOTED.

Items for the November meeting

Low Common, Hellington – Councillor Francis reported that the road was becoming increasingly muddy, and following recent flooding there was nowhere for the surface water to go – at times, the water was up to 10 inches in depth. It was proposed that Gary Overland of the Highways Department should view this road on his next site visit. **The Clerk would contact him to arrange.**

There being no further business the Chair declared the meeting closed at 9.25 pm.
