MINUTES OF THE PARISH COUNCIL MEETING (Draft)

Declarations of Personal and Prejudicial Interest:

It was proposed by Cllr Gibbs that the minutes of the meeting, held on Monday 20th March 2017 be approved by the members with the following amendment. Page 6, 17/45, replace “St Peter’s Church” with “Sea View Yacht Club” This was seconded by Cllr Barraclough with 6 votes for and 3 abstentions.

17/54**Seagrove Bay Public Conveniences:**

Mr and Mrs Paul had written to the Parish Council asking for some clarity on the Parish Council's position with regard to the lease on the new toilet facility. The Clerk circulated the letter and a draft lease from Mr and Mrs Paul's Solicitors for consideration and comment.

The Chairman proposed that the Parish Council enter into a legal transfer with a private landlord as opposed to the local authority. This was agreed by the members. However, it was also agreed that the Clerk submit the lease to legal advisors and work to obtain some revision to make it more straight forward and less complicated.

17/55**High Street Benches and Surrounding Area:**

Cllr Thomas-Foxley presented a proposal to the Parish Council to fund the clearance of the small seated area at the bottom of the High Street as it has become unkempt and needs tidying up. The community partnership usually looks after this area but are short of volunteers and suitable individuals. The Clerk obtained a quote of £120 + VAT from Brighstone Landscaping as an addition to the Grounds Maintenance Contract.

Information and Report:

Cllr Ford-Moore reported that the lifebelt at Seaview Bay was missing from its cabinet. The Clerk will report to the IW Council.

There was also the report of a Dinghy moored on Seagrove Bay promenade. The Clerk will be provided with a photograph to forward to the IW Council.

The size of the bins in certain areas was again called into question. THE Clerk will continue to talk to Island Roads about larger bins or increased frequency of collections.

Cllr Gibbs reported a potential theft of a kayak from the Dinghy Park as some of the surrounding fence is inadequate. The Clerk reported that he will get a quote for some more robust fencing for the PC to consider. He also stated that the railings in Pier Road were dangerous and some people had been observed tripping or falling whilst trying to manoeuvre them.

Prior to the impending local elections, the Chairman thanked Cllr Kalaher for his 8 years of service on the Parish Council. He also thanked all of the Councillors who have served during this Council.
