Westcott Venture Park. In Vessel Composting Unit.

- 1 This application is a departure from AVDC Policy RA32 and if agreed could create a precedent
- 2 The Council is concerned the traffic flow through the new entrance to be established would not be taken into consideration with the main gate flow for the trigger level to establish a new and permanent access to be used by all vehicles, the A41 side of Westcott.
- The Council requests not only the prohibition of HGV's use of Main Street Ashendon (which is designated 'Unsuitable for Heavy Goods Vehicles') but also any other forms of commercial vehicle. The Council is concerned that waste material after treatment (compost and liquids) will be transported through Ashendon by large tractors and tailors (totally unsuitable due to their size and length to use village roads), to local agricultural land to be spread or stored.
