a) Georgina Pyne-Lingham Licensee of the Queen's Head enquired whether the pub could raise funds to have the duck pond cleaned out. Any money raised can be held in the parish council deposit account until the work takes place. SW to get a new quote from a contractor. Work would need to be carried in August to ensure there was a location available to dispose of the sediment.

b) A new duckhouse is needed. GH to ask Pete to quote for building a duck house. GH / Georgina to liaise with the school to run a competition to name or design a new duck house. GH to replace heron and pallet in the pond.
