Dear Mr. Bishop,

I am not a resident of Swaffham but visit frequently to shop and have subsequently used the public toilets on various occasions.

At the moment there are four cubicles in the Ladies' toilets. Very often one or two of these are occupied and I only visit the town at quiet times.

To reduce the number of available toilets from 4 in the ladies, a separate disabled toilet plus whatever facilities are in the Men's down to just 2 is ridiculous.

In a town that has an influx of summer visitors along with an elderly population to not provide adequate facilities is very short sighted and will certainly result in fewer visitors to the town.

With no separate disabled toilet and the baby changing facilities incorporated into one of the toilets, the "traffic" in and out of these facilities will inevitably slow down.

With the cubicles opening directly onto the pavement are people expected to queue in the rain or snow until a cubicle is free?

What are you planning to do for people with medical conditions that make it difficult for them to wait for a free cubicle? Will they be allowed to use the toilets in the town hall?

I have not seen any drugs paraphernalia when I have visited and if the toilets are used for drug taking how will this stop it? Won't people just use one of the two toilets for this?

Maybe the council is planning to invest the money saved from removing adequate facilities in addiction counselling services to help afflicted people?

I am hoping the number of toilets can be increased to a more reasonable number.



Sorry if you are reading this first thing Monday morning - not the ideal topic to start the week! I would like to respond to the consultation on the public toilets in Swaffham town centre please. I am very strongly against gender neutral facilities. Firstly I used to work in a large modern office (the BBC) with unisex toilets. They were always dirty, compared to the single sex facilities in other buildings belonging to the same company.

Secondly I use the toilets in Swaffham fairly regularly (as a middle aged woman, needs must!) and have never seen any misuse of the ladies. I would definitely feel put off and intimidated to use a single sex facility if there was the possibility of coming across men taking or dealing drugs in there.
