**1a. Apologies for Absence**

**1c. To approve the Minutes of the previous Planning Committee Meeting.**

**IT WAS RESOLVED TO** approve the Minutes of 24<sup>th</sup> February 2020. The Chair signed the Minutes.

**2. Public Participation**

No members of the public joined the virtual meeting.

**3. Policy issues including:**

- 3a. Eastleigh Borough Council Local Plan – Before commenting on the Inspector's suggested modifications the Committee agreed to wait for the Borough Council's full response to her letter. Concern was expressed that the Inspector raised the matter of Hamble Lane regarding making the decision of the Strategic Growth Areas and this had opened up the possibility of development on the Hamble peninsula within the new plan. Another concern expressed was about the possible redundancy of the settlement gaps policy given the impact of on the Hallam Site if the policy was withdrawn.

- 3b Update on Hamble Lane Improvements – The Clerk reported that she had asked for an update on the County Council's progress regarding the improvement scheme, in particular the proposed Hamble Halt Station car park and would there be any changes such as cycleways as a result of social distancing relating to the coronavirus. Waiting for a detailed reply.
- 3c Outcome of the Transforming Cities bid, March 2020 – The Committee was disappointed that the Hamble peninsula was not included in the funding but it would pursue other options to make improvements in Hamble's cycleways, footpaths and public transport.
- 3d Correspondence regarding the Community Rail Network, 30.04.20 – Volunteers were being sought to join a community group. A question was raised about the delivery of the station car park. The clerk stated that a reply was pending from Hampshire County Council (HCC)
- 3e. Outcome of the attempt to have the Pill Box on Satchell Lane listed – Historic England had decided not to add the Pill Box to the List of Buildings of Special Architectural or Historic Interest. This would be followed up with Eastleigh Borough Council (EBC) to see whether there were options to protect it linked to the planning application.
- 3f. Letter from Andy Grandfield  
Committee welcomed the response from EBC and the reply that was sent in response highlighting a number of inaccuracies as well as requesting a discussion about the new policy at a future team meeting.
- 3g. Hamble Commons Area Access Management Assessment  
The Chair outlined the options being promoted by Bird Aware who are appointed by Solent Recreation Mitigation Partnership to decide how best to spend developers' contributions to protect migrating birds and their habitats. The draft produced by Cllr Underdown and Cross was circulated to the Committee and their comments were to be made by the end of the week.
