# SHRAWLEY PARISH COUNCIL MEETING

Minutes of the Parish Council Meeting of the Shrawley Parish Council held in Shrawley Village Hall on **Monday 12<sup>th</sup> January 2019 commencing at 7.15pm.**

## **319** Apologies for absence:

From Councillors N Thomas, P Benkwitz & County Councillor P Grove.

## 320 Co-option of parish Councillor:

It was unanimously RESOLVED to co-opt Mrs Jill Griffin to the vacant seat on the Parish Council. Councillor Griffin made the declaration of acceptance of office.

## 321 Confirmation of the Minutes:

The minutes of the previous meetings held on 12<sup>th</sup> November 2018 as circulated earlier were approved and signed by the Chairman.

# 322 Declaration of Interest for a) The Meeting and b) Any Changes to be notified to the Registers of Interests and Gifts & Hospitality;

#### 323 Planning Matters:

Councillor Tesh updated Council on outstanding applications awaiting MHDC determination. Council RESOLVED to support Planning Application 18/01619/HP at Spring Cottage.

#### 324 County & District Councillor's Report

The Council concurred with Councillor Pam Cumming that Malvern Hills recycling collections had worked very well during the Christmas and New Year period. MHDC has approved in the last few months up to 2,365 new dwellings in the Broadheath Ward along with some 1,540 additional University accommodation units. There is concern at the failure to improve infrastructure, particularly roads, which will increase significantly local congestion. It is now understood our approved three entrance gates will be installed at the beginning of April by Worcestershire County Council when they have a separate road closure scheduled. The 4<sup>th</sup> Gate purchased by Shrawley PC had now been sold to Stone Parish Council.

## 325 Clustering of Parish Councils – request by Little Witley Parish Council

It was agreed the Parish Council would support the request from Witley Parish Council to work jointly on a cross parish initiative for closer working arrangements. Councillors Mosedale & Dorrell would represent Shrawley Parish Council on the discussions.

#### 326 Shrawley Village Hall

The Chairman presented a copy of the registration of the title to lease land adjacent to Shrawley Village Hall.

## 327 Parish Grit Bins

The Council noted the refusal by Worcestershire County Council for the 4 previously agreed locations to be provided with Parish Grit Bins. The Council decided to proceed with the purchase of up to 4 bins from Messrs Glasdon as per their quotation dated 10<sup>th</sup> January 2019 as they are considerably cheaper than from the County Council. The first 2 locations are to be at the New Inn and Glazen Bridge, subject to the agreement of the land owners. Clerk was asked to approach Worcestershire County Council to seek support on installing a Grit Bin on the triangle of highway land along Rectory lane.

## **328** New Inn Public House – Asset of Community Value

The Clerk was requested to ascertain from Malvern Hills DC what the procedure is when the current 5 year agreement expires.

## 329 Walk in the Shrawley Woods

The 2019 walk with Richard Boles the Forestry Commission is to be held on 14<sup>th</sup> May 2019 commencing at 5.30pm.

## **330 Grant Applications**
