3376. CASUAL VACANCIES

I have received a notification that ten electors have asked for an election. There will be a period for nominations to be submitted. If there are more than two candidates then a poll will be required, at the polling station at the Matching Village Hall and will have a cost of approx. £2500. If there are two or less candidates there will not be a poll, and the cost will be approx. £500.

Electoral Services have asked if we require polling cards which will involve a cost of approximately £997. It is not a legal requirement for Parish Councils to have polling cards, but they can be provided if required. Decision taken not to have polling cards. Clerk to notify Electoral Services.

3377. MATCHING GREEN AND MATCHING TYE

To consider issues for Matching Green

- Extending club premises licence of MGCC for a full year
- Councillors expressed their concerns regarding noise, nuisance and access to the pavilion during the winter months causing damage to the green.
- Bonfire. Start to build bonfire on Saturday 25th October

To consider issues for Matching Tye

- Still a problem behind Shetlocks when the main sewer collapses. Tankers have been visiting Matching Tye and keeping the problem under control. The pipes are 4 metres underground, and it is only a 150 mm drain. Unfortunately if there is a problem elsewhere, tankers can be called away, leaving Matching Tye with a potential drainage problem.
- VAS signs in Harlow Road are not working. Clerk to notify Highways.
- Bench on the Matching Tye Green is not repairable. PM is looking into replacement costs

The Cherry Tree, Matching Green, Matching, Harlow, CM17 0PT; EPF/1561/25; Approval of Details Reserved by Condition 4 (Large Scale Details) of EPF/1727/24 (Grade II listed building application for a proposed two storey side extension, part retention, alteration and repairs of existing single storey rear extension and part replacement of existing single storey rear extension). **APPROVED**
2. Downwood, Matching Road, Matching, Harlow, Bishops Stortford, CM22 7AS; EPF/1427/25; Prior approval for change of use from commercial (Class E) to dwelling (Class C3). **APPROVED**
3. Tadgells Barn, Carters Green, Matching, Harlow, CM17 0NX; EPF/1371/25; Approval of Details Reserved by Condition 7 of EPF/1907/22 (Proposed outbuilding ancillary to the main dwelling to house Gym, Sauna, Solarium, Spa and Steam Room. This has previously been refused under appeal.
