928. Declarations of interest. There were no declarations of interest
929. Resolution to sign and approve Minutes of Regular Meeting dated $21^{\text {st }}$ March 2016 and interim meeting dated $4^{\text {th }}$ April 2016.

## 930. Matters Arising - from previous minutes for updates only

It was agreed that the Clerk would prepare a draft letter to be sent to all dog owners in the parish

Following the decision at the meeting on $4^{\text {th }}$ April 2016 to purchase 50 of these medals the Chairman reported that she had successfully sourced suitable envelopes and labels to contain the medals. These will be distributed to all children in the parish up to the age of 18. Sue Stanley agreed to supply a list of names.
931. Planning Approvals - Review of Past Planning Applications
i) DA/2015/0195 Land at Stowe Hill, Watling Street. Land for one Gypsy Pitch A reply had been received from the District Council regarding the elevation of our complaint to Level 2 indicating that under this procedure the review would be undertaken by a senior manager of the Planning Department. As this manager was named in our complaint the Parish Council felt that we should write back to the District Council objecting to this situation and asking for another senior manager to carry out the review. This course of action was agreed by a majority vote of five votes for and one vote against. Graham Yandell said that he may also write as an individual objecting to this procedure.
ii) DA/2015/1164 Land adj. Sheepfold Grange, Main Street, Upper Stowe

Prior to discussion of this item Councillor Brodie, having declared an interest, left the meeting. The Clerk reported that the application was still under consideration by the planning officer and that there was no indication when this might be considered by the DDC Planning Committee. The Clerk was asked to establish whether it might be possible for more than one speaker to be allowed to address the Planning Committee as a representative of the views of the individual objectors.

## 936. Community Infrastructure Levy (C.I.L.)

New guidelines have been received from DDC. This could provide valuable funding for the parish should there be any future new build properties.

## 938. Canal Cottage

The Clerk has spoken to Paul Knight, DDC Environmental Health Manager, who has advised that Canal Cottage is now in the hands of the Official Receiver. There is therefore little value in pursuing a Community Protection Order. We must await the action of the Receiver

## 939. Vacancy for a Parish Councillor

Councillor Sue Stanley has decided to retire from the Parish Coumcil. The Chairman paid tribute to the work that Sue has done for the last 17 years both as a Councillor and as Chairman of the Council. She presented a gift to Sue from the Parish Councillors.
The Clerk will post notices of the vacancy and also notify DDC Elections Office. If there is no call for an election from 10 or more electors within 14 days the Parish Council will be give powers to co-opt to fill the vacancy.
