## S106 Proposal for Play Projects in the Recreation Ground

The S106 Play Projects are to provide the following in the Woolton Hill Rec:

- Boules Court
- Fixed Exercise Equipment
- Table Tennis
- Picnic Tables/Seats

The approximate layout for the first two elements are included at the end of this document.

### **Boules Court**

The quotes for a 9mx12m (3 lane) Boules Court are as follows: (numbers excluding VAT)

James Dean £13,130

CEGroundworks £8,368

RL Lampards £10,641 (need to add inflationary increase for exact comparisson)

This is a slightly different request to what groundwork comparies are familiar with but both James Dean and Andy Batt from CEGroundworks gave confidence that they knew what was required, especially the amount of material to be removed (about 50ton), connecting to existing drainage and the materials to use. Although very willing, Lampards were not so reassuring.

CEGroundworks have direct experience of undertaking a Boules Court. Their quote is included later in the document.

Consequently, given their experience, capability and quote value, I recommend we proceed with CEGroundworks and contact them with authorisation to proceed.

As per usual we will assume an additional contingency, which I would suggest is 10% and we may want to consider changing the border from sleepers to a shin high fence. (see quote)

## Fixed Exercise Equipment.

The Exercise equipment is to be supplied from The Great Outdoor Gym Company www.tgogc.com and comprises of Full Body Multi Gym, including: Leg Press, Cross Trainer, Lat Pull Down/Shoulder Press

The price for this excluding VAT is £10,405.00
