# Minutes of the Meeting of Droxford Parish Council held at 7.30pm on Thursday 19th November 2015 at Droxford Village Hall

**150.15** To approve apologies for absence: There were no apologies for absence from councillors at the meeting.

*Clerk's note - Cllr Toman left a telephone message before the meeting which was not picked up until after the meeting.* 

**151.15** To receive declarations of disclosable pecuniary and non-pecuniary interest Cllr Acciarri declared a potential disclosable pecuniary interest in the Planning Report item 1.2.5

With Members' agreement the running order of the agenda was altered.

**152.15** Two members of the public were present, John Dryden Brownlee, Friends of Droxford Church (FODC) and Richard Baxter, Hon Treasurer of the Village Hall Committee. Cllr Huxstep asked leave to speak first due to being required to attend 2 more meetings afterwards. He also apologised in advance for not being able to attend the next meeting. He will send a written report,

#### 153.15. County Councillor's Report:

**Broadband:** Fibre is to be laid in Droxford in <u>Phase 2 of Wave 2</u> sometime between January and December 2017

**Devolution bid:** HCC Cllr Roy Perry and other leaders of the HIOW group of authorities to wait until end of November fora decision from the Secretary of State.

Budget: HCC hope to minimise impact on front line services in £100m cuts.

**Minor Works Bid:** Droxford's bid for minor works to highways was not listed for priority funding under the County Council's small grant scheme. Cllr Huxstep advised approaching Highways directly to resurface the Swanmore Road/A32 junction approach.

# 154.15 Request for a Statement of Support for the FODC application for a grant from HCC

John Dryden Brownlee opened discussions by saying that said the reason for seeking finance is to fund an extension to provide a Rector's room, kitchen and toilet facilities to service secular and community activities. FODC Droxford Community Hub and Heritage Project has been shortlisted to apply for a grant of £150,000 from HCC by 17<sup>th</sup> January. This is in addition to a first round pass of £33,900 awarded by the Heritage Lottery Fund towards a full grant of £217,500 for essential repairs and restoration, upon condition the church is used by the wider community. Support of the Parish Council is being sought in addition to that already pledged by Droxford Junior School, Montessori School, Cllr Huxstep, Cllr Dibden and the Village Hall Committee.

Richard Baxter, Treasurer of the Village Hall Committee confirmed the Committee is fully supportive and views proposed activities as complementary to the Village Hall. Toilet facilities located in the Church for walkers and church users will alleviate disruption to village hall activities. Mr Baxter, who is also the liaison officer between the Village Hall Committee and the FODC, emphasised both organisations need to maximise bookings without one functioning at the expense of the other. The Council debated two principal concerns at length; sustainability of ongoing maintenance without Resorting to dwindling numbers of church goers, and financial viability of projected income generated by non-secular activities. Mr Dryden Brownlee said the activities had already been evaluated and recognised as viable by the HLF. The Café would provide a facility for events and income ploughed back into the Church. Such facilities are required for large events to attract interest from the wider community and beyond. Although matched funding will be needed of between £80,000 - £150,000, he assured the Council no funding will fall on the Church; a number of individuals have been approached by FODC and will be donating to the project.

The Council expressed there should be close collaboration between the FODC, the Village Hall and the PCC.

Mr Dryden Brownlee assured the Council that the PCC are the owners on whose behalf the FODC work. The Diocesan Advisory Council and Historic England also support the project. It will be the largest inward investment opportunity that the village has ever had.

The Council proposed to ask the FODC to provide further information:

1. To clarify sources of matched funding

2. Anticipated income generation from the proposed new users of the building and how this will close the previous endemic gap between income and the costs of operation and ongoing maintenance of the existing church building.

3. Provision for annual overheads and projected maintenance costs of the project.

Mr Dryden Brownlee agreed that the FODC would supply financial forecasts set against the activities proposed for the Church. The PC will send a letter requesting this information.

The matter will be on the agenda for the next full council meeting on Thursday 10 December.
