Building the Evidence Base

Affordable Housing

AH explained that he, MB and Steve Blakeman were meeting with individuals from the Wessex CLT project at the beginning of March. This is a group that provides comprehensive support to Community Land Trusts throughout Devon. The purpose of the meeting is to explore whether a Community Land Trust will be the most effective way of meeting affordable housing need and managing other community assets such as a parking facility.

Settlement Boundaries

AH explained that he understood the emerging Joint Local Plan ('JLP') may continue to allow for the creation of settlement boundaries. The Group was generally in favour of retaining one for Exbourne, if possible, but recognised the current boundary may need to change to allow for the levels of development envisaged by the JLP. MB raised concerns over the enforcement of a settlement boundary given the National Planning Policy Framework and subsequent guidance seem to steer permission towards any application that can be regarded as "sustainable".

Parking

AH explained that he had discussed parking facilities further with the Group's planning consultant, Stuart Todd. Stuart had indicated that, if a parking facility was put forward in a site assessment presented to the public, then specific proposals would need to be agreed with the landowner, including the size of any land set aside and potential costs. Highways should also be consulted. The Group agreed that these aspects should be explored further once the updated site assessments are published with the latest version of the emerging JLP in mid-March.

Local Green Spaces

AH had circulated a proposed publicity poster and display board material for the "Local Green Space" community consultation the Group is holding throughout March. AH explained that he intended for the display boards, nomination forms and further information on Local Green Spaces to be available at the Burrow, Village Hall and on the Neighbourhood Plan website at np.exbournewithjacobstowe.org.uk. It was suggested that the map showing current Important Open Spaces could be clarified and a few examples given. MB agreed to provide some examples. GL kindly agreed to set up the displays. AH agreed to amend the display board material.
