**PH wanted to say how he enjoyed his visit to the Jingle Tingle at the Memorial Hall.**

**PH told the meeting that he had met up with the LAT. He said that they looked at the various potholes around the village. Those mentioned were Hedgerley Hill, Kiln Lane, Stevenson Road and Cottage road mouths. NC mentioned Jones Way . The problem of the dip in Hedgerley Lane; would be keeping an eye on whether things deteriorate further.**

**Kemsley Wood 'den' - following discovery of a den being built in the wood and the resulting very large amount of rubbish being left around, Councillors requested that David Vincent be contacted to deal with the problem.**

**Parking in Jones Way - it had been observed that vehicles had been parking on the Green opposite Jones Way. It was suggested that the Clerk get in touch with the contractors who are working on No.11 to ask if they had been parking there. If this was the case, the contractors would be asked if they could desist.**

**Driving on the Green - Councillors were informed that a vehicle/vehicles had been seen driving across the Green. A resident who had seen this happening managed to take the registration number and informed the Police.**

The quotations should be received before the next meeting. The consultant will be undertaking a resistograph test on the large oak at the end of the Green to its condition.

### **Stile on Hedgerley Hill**

The quotation was for either softwood timber (£260) or, as the contractor suggested, Hedgerley milled timber in hardwood (£380). Councillors approved the hardwood quote.

### **Permission to hold 'wassail' in the Orchard on 9<sup>th</sup> January**

### **Bench in memorial to the late Ted Evans**

NC was writing the wording for the commemorative plaque to put on the bench.

### **Kiln Wood Management Plan access**

As the lower part of Kiln Wood is almost due to commence, Councillors were asked their opinion for the means of access for getting into that part of the woodland and to actually get the timber out. Councillors were concerned that there would be too much mess on the road. Further thought on this for the next meeting.

## **9. Slade Farm**

PH told the meeting that he had met with the Case Officer at County Hall. He referred to the Aggregate Assessment 2015 which would add considerably to our cause. He said that Highways Development Control for clarification information. PH said if it was assumed to be turned down because it was not viable for transport reasons. He said he would persevere with this in the next plan. Building development in South Bucks will have the effect of sterilising the area once it was built. PH said this was not the time frame; possibly it will be February. He considered the Case Officer would refuse it.

He also commented that he found the public meeting held recently in Hedgerley was very helpful. NC said that something would be put in the Community Plan regarding planning, then start with the Neighbourhood Plan.
