Minutes of the Parish Council Meeting held in Stalisfield Village Hall on 14 August 2023

1. Apologies

Apologies had been received from Cllr Richard Vant (work) and Cllr Nina Williams (personal); apologies accepted.

2. Declarations of interest

None were declared.

3. Minutes of the Annual Parish Council Meeting Held on 18 May 2023

Cllr Horn read the minutes.

It was **AGREED UNANIMOUSLY** to accept the minutes as a true record.

4. Matters Arising from the Minutes

Cllr Horn reported that the wood for the memorial bench has been sourced, it is anticipated that two benches and a table will be made from it.

The gateways were to be installed on 19 July, but KCC Highways have informed the Council of a new date for the installation on 22 August.

The Clerk reported that Cllr Lehmann had informed the Council that the Local Authority will not pay for EV points.

6. Planning Matters

i. Ref: 23/503121/LBC

Proposal: Listed Building Consent for internal and external alterations including the erection of a single storey rear extension, a single-storey glazed 'Link' from farmhouse to adjacent outbuilding rear extension including conversion of outbuilding into a habitable space. Erection of a verandah to front elevation, installation of a new chimney stack and changes to fenestration. Demolish existing attached garage block and erection of a detached 3-bay garage block with loft store above.

Proposal: Erection of a single storey rear extension, a single-storey glazed 'Link' from farmhouse to adjacent outbuilding rear extension including conversion of outbuilding into a habitable space. Erection of a verandah to front elevation, installation of a new chimney stack and changes to fenestration. Demolish existing attached garage block and erection of a detached 3-bay garage block with loft store above.

Councillors considered the applications and noted the Conservation Officer's report which requested further information on some aspects and also some amendments. The report also raised concern that the bull sheds, which are an important element of the original farmstead

and important to the setting of the adjacent farmhouse in reinforcing an understanding of its function, were being ignored again.

Councillors agreed that there were no objections on the understanding that the Conservation Officer's comments are implemented.

ii. Proposed Telecommunications Installation for EE UK Ltd

Councillors considered the proposals and noted that this was a preliminary enquiry. It was considered that further information be requested: Will the mast will be visible from the nearby houses? What is the nature of the generator? What cable laying will be required? Will it be solely for blue light services? Some areas of Stalisfield are in a black spot with no mobile reception.

It was **AGREED UNANIMOUSLY** to pay Stalisfield Village Hall £11.25 for hall hire (cheque no 319)

Cllr Vant has reported pot holes to KCC Highways.

9. Any Other Business

No other matters were raised.

PC Gary Morris introduced himself as the new Kent Police neighbourhood beat officer for Boughton and Courtenay, East Downs and Watling wards. Kent Police have re-introduced beat officers which has brought back neighbourhood policing and there will eventually be one officer per ward. Since the Council's last meeting there has been no crime reported in the parish. My Community Voice is a good way for the beat officers to communicate with residents.

Cllr Horn thanked PC Morris for attending.
