- a. **20/00453/FULLS:** Redburn Farm Green Pond Lane SO51 9BR, Rebuild existing outbuilding (Mr And Mrs Ardani). **Comment: "No objection"**
  - b. **20/00247/FULLS:** Beech Hollow Baddesley Road SO53 5NG, Single storey extension to re-configure living accommodation (Mr And Mrs Gunatilake). **Comment: "No objection, comment: Access to the gated property is by a narrow public footpath. Works traffic needs to be managed to ensure that public access and safety are safeguarded."**
  - c. **20/00430/CLPS:** Ampfield Golf Club Winchester Road Ampfield Romsey Hampshire SO51 9BQ, Certificate of proposed lawful development - Carried out a material operation on site through physically commencing implementation of planning permission 16/02016/FULLS via the digging of the required foundation trenches and subsequent concreting, fully in line with the requirements of Section 56 (4) of the Town and Country Planning Act 1990. As such the referenced planning permission has been perpetuated. (Mr Adrian Barker). **Comment: "No Objection".**

- d. **20/00473/TREES:** *The Old Police House Green Pond Lane Ampfield SO51 9BR, T1 Oak - reduce the crown by 2m and crown lift up to 4m clearance from the ground level (Mr Gerald Hatch).* **Comment: “we are content to rely on the opinion of the tree officer.”**
