# 4. To confirm & sign the minutes of the meeting held on 11 July 2017

# 5. Matters Arising

## a) Website

Councillor C Tunbridge confirmed that the website was up to date. The Chairman asked for a direct link to the New Inn to replace that to the Salvation Squad.

# b) Replacement Notice Boards

Councillor D Stone confirmed that the notice boards would be replaced in the near future now that he had purchased the posts which were needed for the installation.

# c) Emergency Plan

Councillor S Easterbrook agreed to set a date for a primary meeting and to create and circulate a flyer to promote the meeting, which was to be held at the Church Rooms to discuss a revised Emergency Plan. This was to be called 'Developing Wolverton's Emergency Plan'.

# 6. Report from Warwickshire County Councillor – Councillor J Horner

Following the August break, Full Council was held on 21 September 2017.

August saw the launch of this year's County Council community grants scheme. This scheme invites community groups to apply for grants of up to £1,000 for schemes that will increase community cohesion.

A meeting of the Parish Council Chairs from Arden Division was held last month and it was decided that it was worth holding quarterly meetings of Parish Council Chairs and Clerks.

The Police were facing demands on their resources to tackle national and regional problems of organised crime, terrorism and cybercrime.

The Local Flood Grants scheme is now open. The annual grant scheme, to help communities address local flooding issues is open for applications. # 7. Report from Stratford District Councillor – Councillor P Richards

On Monday 11th September the Council received its final report from the Planning Inspector on the CIL Policy and a copy of that report will be available shortly.

Earlier this year SDC produced and consulted on a Draft Transport Strategy, in conjunction with Warwickshire County Council.

In July this year the Government announced a new Housing and Infrastructure Fund that will provide a total of £1.2bn of funding to Councils to help fast track infrastructure projects that would unlock housing schemes.

There are two forms of application, one called Forward Funding that is only available to County Councils to a value of £250m. The second called Marginal Funding, which is available to District Councils up to a value of £10m.

SDC have a list of projects it is seeking to put forward for marginal funding, including bids for the Gateway Project, the Canal Quarter and the Long Marston Garden Village.

SDC have also requested that a Forward Funding bid be put forward by Warwickshire County Council, to assist with the delivery of the LMA site and the infrastructure that surrounds it, including the SWRR. That view has been accepted by the County Council along with three other bids they have a desire to bring to fruition.

In 2015 a task group was established by SDC to consider ways in which it could help in the delivery of affordable homes across the District. That working group was then superseded by a Cabinet Working Group in January 2017, to continue the work and bring forward a delivery plan.

Consideration has been given to a number of different options including direct delivery of housing, community delivery, partnership working, and joint ventures and establishing a wholly owned local housing company (LHC).

At Cabinet on Monday 11th September, approval was given for the Working Group to progress with a business plan for a wholly owned LHC.

Councillor Paul Anthony raised the issue of the external lighting at Woolley Park Farm — relating to its necessity, light pollution and glare affecting road users. It was suggested that when these were first erected, they did not infringe planning regulations as they were fixed to the buildings. It was agreed that the Clerk would contact Councillor John Horner regarding the matter.
