NSDC – update from Roger Jackson

The Conservative party are now the largest group at Nottinghamshire County Council following elections held on 4 May 2017, winning 31 of 66 seats, so Notts County Council is currently governed by a coalition of the Conservative Party (31 seats) and the Mansfield Independent Forum (4 seats).

The Minerals Plan has been cancelled but is going to be re-written over the next two years because there are reserves for several years.

Network rail car park – discussions are to take place with Network Rail, while they are on site, about the car parking issues around the station in the hope that a solution for the problem can be found.

The culvert opposite The Byars has been reported by a resident as still non-flowing. Councillor Jackson confirmed that Notts County Council has agreed to look at this with a camera and rectify this if necessary. However, it is unclear what, if any work, has been carried out so Councillor Jackson will make enquiries and report at the next meeting.

Proposed cuts to the school bus service mean that from 2018/19 over 16 year olds will be unable to travel on school buses, although the school buses will still be running. At present, the proposal is that there will be no option for them to pay to still use the service. Councillor Jackson and Roger Jenrick MP are
