#### 46/25 Members of the Public:

Shropshire Councillor J Dickin gave an update on Shropshire Council issues relating to the Travellers Site, resurface of Corvedale Road Craven Arms.

Councillor J Dickin will try and obtain an update on the proposed improvement to the gulley gate by Stokesay Hotel.

The Town Council expressed thanks to the contractors for the work undertaken on Corvedale Road and for completing the work earlier than anticipated.

#### 47/25 Declarations of Interest:

Cllr D Evans and Cllr S Demos declared an interest in the confidential item regarding the sale of the Council land Corvedale Road Craven Arms for which they left the meeting and took no part in the debate or decision of the Council.

**48/25 Minutes:** - The Town Council confirmed the minutes of the meeting held on 24<sup>th</sup> June 2025 and they were duly signed by the Chairman.

## 51/25 Amenity Items:

- a) Craven Arms Playing Fields It was pleasing to note that the field was being used by a local football team for the forthcoming season.
- b) **Craven Arms Flooding Scheme** Cllr R Pitt is organising a voluntary clearance of the watercourses with the Riparian landowners to be undertaken during September 2025 gave an update on progress made however after delivery of letters made was disappointed at the response for volunteers.
- c) Other Amenity Items The benches outside the Craven Arms Bowling Club were in the need of cleaning Cllr S Demos agreed to pursue with the volunteers from Stret Scene.

## 52/25 Highways Items

The Clerk had produced a report on the "Consideration of the upgrade of the Town Council Streetlights to LED lighting" which would result in a significant annual revenue saving in energy costs and future maintenance.

In converting all the streetlamps to LED lamps would potentially save £4,500 in annual running costs together with savings in annual maintenance costs.

The Town Council has 86 streetlights - 45 with steel columns and 41 with concrete columns - with 10 streetlights converted to LED lamps.

Converting the streetlights to LED lamps on the existing 70 columns will cost approximately £21,000, depending on the condition and suitability of the concrete columns.

The Council considered if it would be opportune to replace the old existing concrete streetlights some of which are over 25 years old to steel streetlights the cost to undertake this would be in the region of £75,000 plus unknown Traffic Management Plan costs.

The Council after considering the Clerks report agreed to convert the existing streetlights at an approximate cost of £21,000 and look to a planned replacement program to replace the concrete streetlights over the next 5 to 10 years and to set aside from existing reserves £100,000 to the Street Lighting Reserve Fund to meet the costs.

The Council are aware that some concrete streetlights may have to be replaced to enable a conversion to LED lamps however this will not be known until the initial conversion program is being undertaken. The Town Council agreed to appoint Highline Electrical Ltd (Subject to Contract) to undertake the work with the Clerk reporting back to the next meeting on the contractual proposals for the replacement of any concrete streetlights.

#### 53/25 Financial Items:

The Clerk had produced an Income and Expenditure Statement which showed that the Council had balances of £245,655.77 at the 2 9<sup>th</sup> July 2025 following approval of the expenditure listed below, and a statement of the balances held in the appropriate bank accounts to comply with the Council's investment policy. The Town Council had received a payment of £8,276.28 from Shropshire Council in respect of the Neighbourhood Fund CIL contribution.

The Town Council approved the Statement and the accounts for payment.

The Clerk had produced a report giving the background to the Sale of the land, Powers available to Local Councillors on the Sale of the Land, Legal requirements in Consideration of the Sale of Council Land which had been undertaken by the Council, the Present Position and requests that had been received in respect of the land.

The Council considered the requests and options, after which it was proposed by Councillor J Fuller and seconded by Cllr N Carter and agreed by a vote seven for and one against that the land be sold to Bramley Property Holding Limited who had obtained planning permission for the development of two houses on the site.
