Queries raised from a member of the public:

- With regard to the existing infrastructure in the village is it suitable for the additional housing already permitted at Collingham Brook?
- Traffic is a particular issue along the High Street
- The proposed access to the proposed development on Woodhill Road is an issue. Where it is proposed requires the removal of a copper beech tree with TPO (temporary) and the bus stop to be relocated but no new location has been suggested
- Flooding on the site is an issue as the site has flooded almost every year in the last 10 years, predicting waterflow is not always possible
- Is there any possibility of any of the other mature trees being considered for a Tree Preservation Order?

Another member of the public, supported the previous speakers comments and added:

- The proposed development on Woodhill Road 26 houses appears to be too many for the site
- Some development on the existing building lines would appear to be more appropriate

A third member of the public raised the following items:

- Inflation is 2.3% and is significantly less than the increases in car parking charges at the station, how is this justified?
- It is understood that the Royal Oak Steering Group and LCS have come to an agreement over a 5 year lease
- Road markings which have recently been put on the High Street are supported but who is going to police this?
- Micro-brewery application, this will have an odour associated with it

HGVs have been running down Station Road to the Girton fisheries – checks are being made about the planning permission and if this is now in breach Healey Close is now likely to be resolved

Material planning considerations: Design, Privacy, Access, Ecology, Cumulative impact for both traffic and flooding, Planning History and related decisions (Oaklands) Water system put in on Millenium Green to prevent flooding by using the rain water – this proposal could cause contamination to an award winning development This site is not accepted as a development site in the NSDC development framework NOT SUPPORTED unanimously
