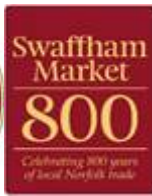

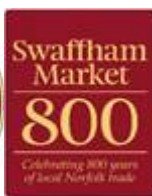

We are including you as part of the consultation and would welcome your feedback before 10th August 2021.

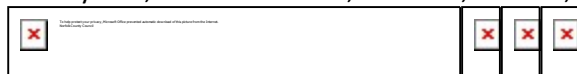
