

Minutes of the Meeting of Lenham Parish Council Held on Wednesday 7th December 2022 at 7:30pm at Lenham Community Centre

PRESENT Cllr. J Britt, Chairman presiding.

Cllrs. M Cockett, K Hammond, N Osborne, A Ratcliffe & S Heeley from 8:15pm (22/109) J Bate RFO, L Westcott Clerk 3 Members of the public.

Public participation

1 member of the public stated that the Maidstone Road/Ham Lane footpath is uneven, Cllr. J Britt reported that this was being looked at, but due to the number of different parties involved it is not straight froward. It was also requested that the list of current Cllrs. be included on the notice board, L Westcott will put the revised list up. It was also requested that the road names on the new housing developments be included in the Lenham Focus articles.

1 member of the public from the Ham Lane Allotment Association advised that a delivery of manure was received. The AGM will be held in February and will need an update on the land registration. There was a query over the opening times in the planning permission for the nursery being in contradiction to the Nursery business plan, Cllr. A Ratcliffe advised that the planning conditions would be followed. There was also a question regarding minutes and if they are legally binding, L Westcott advised that the minutes provide a public record of the decisions made by the council at that time.

L Westcott read out the report from MBC Cllrs. T & J Sams:

- Local Plan Review The information at the MBC Local Plan hearing was presented in a clear articulate way by all and was a credit to the community.
- **Boundary Commission** MBCs second proposal to split the parish was well and truly quashed by the LGBCE who felt that splitting communities was not a good idea.
- Highways We have continued to report highways issues, particularly at this time, drains and flooding.
- Warm Space A warm space Hotspot@SocialClub will be running on Tuesdays, Wednesdays and Thursdays mornings 9.30-1pm and we are very grateful to the Social club for hosting.
- We would like to wish all the parish councillors, Lisa & James a merry Christmas and express our great appreciation for the mammoth efforts they have made on so many fronts for the community as a whole

1 member of the public asked for the following statement to be read as they couldn't attend the meeting: "I just wanted to congratulate you on your choice of outstanding planning advice from Paul McCreery and your equally excellent legal representation at the recent inquiry into the Local Plan review. It is the second Local Plan Inquiry which I have attended, where Lenham's future as a pleasant, rural community is threatened by overdevelopment. I am quietly optimistic that the outcome will be positive but, in any event, I wanted to let you know that, in my opinion, you could not have done a better job. I know it was expensive, but the people in Lenham would have hated it, if you had not tried."

- c. Warren Lands Cllr. J Britt declared an interest. Two parallel legal challenges are taking place, with different submission dates. An inspector is visiting on 16th December. LPC responses need to be organised.

L Westcott updated Cllrs. on the proposals to cut numbers of PCSOs and remove them from covering specific areas with a plan to allocate a Police Officer to each area. Cllr. N Osborne suggested that LPC write to the inspector to express our disappointment as this will affect the policing in Lenham. **ACTION** All to send comments to Cllr. J Britt to draft a response.

22/117 TO CONSIDER REMOVAL OF SMALL TREES AND BRAMBLES AT THE ALLOTMENTS FOR £250

Down to Earth have provided a quote of £250 to remove small trees and brambles on the waste pile that are causing damage to a neighbouring fence. Cllr. A Ratcliffe proposed, Cllr. N Osborne seconded and it was **RESOLVED** that to approve Down to Earth to complete the work. **ACTION** L Wescott to instruct Down to Earth.

22/118 TO AGREE DESIGN WORK OF QPJ BROCHURE

L Westcott circulated the draft QPJ Brochure, there are two blank pages needed to be filled. Cllrs. suggested "Quotes from the day" and a list of "Memorable events in Lenham throughout the Queens Reign" plus a note about the Queen's death. **ACTION** L Westcott to draft pages and circulate.

22/120 PROJECTS - TO REPORT UPDATES/ REPORT OF OUTSIDE MEETINGS ATTENDED

- a. Remembrance Day Cllr. A Ratcliffe reported that the Remembrance services went well.
- b. Lenham Meadows Trust Cllr. N Osborne reported that ownership of Kettle Meadow is going through.
- c. Lenham Nursery Cllr. N Osborne reported that the fundraising guiz was very good and well attended.



- d. KALC Maidstone meeting Cllrs. J Britt and K Hammond feel that these meetings require reorganising. Issues raised during the meeting are: MBC are low on (planning) enforcement officers, the Police restructure will be the main item on the January agenda.
- e. Footpath Cllr. A Walmsley provided a written update on the tree works planned along the footpath he has been liaising with the residents of the Russells and L Westcott is applying to MBC for approval to work on trees in a conservation area. A S106 application will be made to fund the project. L Westcott asked if LPC should notify the insurance company of the issues all agreed to do so.

ACTION L Westcott to apply for S106 funds and notify the insurance company.

22/121 CORRESPONDENCE

- a. L Westcott has received an email regarding lorries presenting a hazard on rural roads particularly between Lenham and Sutton Valence. Cllrs. agreed this is a danger and the MP is aware or the issues lorries are causing on rural roads. Lorry watch was suggested as an option to review.
- b. L Westcott has received an email stating that Lenham Storage workers are parking outside the shops in Honywood Road all day, blocking these spaces for customers. Cllrs. suggested the member of the public contact Lenham Storage directly.
- c. L Westcott advised that a food bank has been set up in St Mary's church.
