3. Planning Applications Received for Consideration.

- a. 3/02/23/009 Replacement of flat roof over kitchen with a pitched roof and replacement of flat roof over detached garage to a pitched roof Beers Cleeve Cottage, Forches Cross to Brompton Ralph, Brompton Ralph, Wiveliscombe, Taunton, TA4 2RU *no comment*
- **b.** ABD/02/23/002 Prior approval for change of use of agricultural building into 1 No. dwelling house (Class C3) and for associated operational development Little Parks Farm, Gandstone Cross to Parks Lane, Brompton Ralph objects

A member of the public spoke objecting to ABD/02/23/002 and all other members of the public present stated that they also objected to this planning application.

A discussion was held, and the Council unanimously resolved to object as there was doubt it meets the criteria for a Class Q application, works have been undertaken on the structure, the previous reasons for refusal, including that of highway safety which remains. The Clerk to submit the objection comments to Somerset Council.

4. Brompton Ralph Village Hall Christmas Event – Cllr Holmes declared a personal interest and withdrew from the discussion and voting. A request for financial support for a community Christmas event to be held at the Village Hall had been received. It was reported the event would be a meal with Santa Claus in attendance and any profits occurring would go to Brompton Ralph Village Hall. It was proposed by S Baker and seconded by P Heard and it was resolved the Council in accordance with its powers under section 137 and 139 of the Local government Act 1972 should incur the following expenditure which, in the opinion of the Council, is in the interests of the area or of its inhabitants and will benefit them in a manner commensurate with the expenditure and to support the event to the sum of £200 and unanimously approved.
