27 Public Forum

- PC Spencer came to speak about the increase in burglaries for small business owners to raise awareness of the issue and provide support to try and tackle the issue. These are mainly on the High Street and there has been an increased Police presence both on foot and in vehicles to try and deter this. There are other incidents which have also been reported to the Police. Incidents such as this need to be reported on 101 and these should then be brought to the attention of PC Spencer
- A member of the public suggested that the closure of the Police Contact point has contributed to the increase of such incidents
- A member of public came to speak on the revised bus service timetable. The changes to the route will be commencing on the 8th April, there is concern about the Saturday service which is being reduced from 12 buses to 5. The service to the outlying villages has been increased to reduce rural isolation. It would appear that lessons have not been learnt from previous reductions to the service. The Parish Council will be discussing this matter later on the agenda
