

# East Drayton Parish Council

Minutes of a Meeting of the Parish Council held  
at 7.30pm on Tuesday, 21st February 2012 in the Village Hall

## Present:

Cllrs N Stanley, A Stanley, I Stephens, H Mackintosh, M Goddard, P Ogle and R Small. In attendance: Clerk, S Pickard. Members of the public: 0.

1 **Apologies for Absence** – were received from CCllr Hemsall and Pc Bailey.

2 **Minutes of meeting held on 17<sup>th</sup> January 2012** - were approved and signed.

## 3 **Matters Arising**

a) Painting of red 'Phone Kiosk – Cllr Mackintosh reported that Mr Martin Hudson had kindly agreed to paint the 'phone kiosk in the Spring.

b) Overhanging branches at property on Top Street - The Clerk advised that Karen Nurse at Nottinghamshire County Council had emailed on 23.1.12 to confirm an inspector will deal with the matter.

c) Priority Setting meeting for Safer Neighbourhood Groups – The Chairman reported he had intended to go to the meeting, but contacted Pc Bailey and he advised it would mainly be concerned with larger villages such as Misterton and Tuxford; and the main topics would be anti social behaviour, speeding and littering. The Clerk advised the minutes and a subsequent update had now been received and they would be placed in the circulation folder.

## 4 **Police**

The Clerk read out an email from Pc Bailey concerning the new Police Commander, Superintendent Fretwell: "..... and he has been reviewing our current practices with regards to some aspects of neighbourhood policing. One of the things that he has reviewed is the attendance at Parish meetings by Beat Officers and he has put out the following instructions.

1. Beat Officers will not attend Parish Meetings, but will try and structure in Parish 'walkabouts' to occur in the hour or so before the meetings start. This is so that persons attending the meeting will have the chance to speak with their local Officer. (From my knowledge, the attendance at meetings by members of the public is minimal).

2. No crime figures will be sent by email. This is because the crime figures are now available to all at [www.police.uk](http://www.police.uk) and clerks can obtain these themselves ....."

After discussion, it was AGREED to reply (with a request this be forwarded to Supt Fretwell) that the new instructions have been met with total dismay. An invitation to be extended to Supt Fretwell to attend a future Parish Council meeting and a preference for Pc Bailey to attend Council meetings for 15 minutes rather than a walkabout the village that it is believed would not achieve anything. A note of thanks to Pc Bailey for his support in the past to be made and a reply from Pc Bailey and/or Supt Fretwell by the next meeting was requested. **ACTION: S Pickard.**

iv) Street light defects – the Clerk advised Karen Nurse at Nottinghamshire County Council had emailed advising the street lighting team will deal with the issues. The Chairman added that street light no 6 is still out and he had spoken to Karen Nurse again today. Concerning the switching off of street lights overnight, the Chairman will be contacted when this is imminent. Cllr Stephens added another street light was out and would email the Clerk with details later. Also the road sign North Green has been hit by a vehicle and the Give Way sign on Church Lane at the crossroads also needs attention. Clarification from the County Council's solicitors is still awaited concerning the separation of the village name/30mph signs. Also the pothole near Cllr Small's property has worked loose again and the length of Low Street also has numerous potholes. **ACTION: S Pickard.**

v) The Chairman highlighted the ongoing problems concerning Alert messages and the Neighbourhood Watch Association – neither is working satisfactorily at the moment. Further investigation required. A further paragraph to be added to the email to Pc Bailey concerning this matter. **ACTION: The Chairman.**
