18.47 PUBLIC PARTICIPATION SESSION

County Cllr L Burr reported:-

- Cllr L Burr attended the Joint Minerals and Waste Plan debate at NYCC to get the best deal possible for Ryedale. A strong letter was sent from RDC planning making representation at county, Cllr Burr was voted to speak on behalf of Ryedale. The main amendment was the 500 metre limit away from any housing development, which corporate companies are against. The current plan is going through the motions at the moment, it is intended that this will be challenged.
- The HGV ban is currently in force, this is being assessed at the moment. It is felt that it has helped the traffic congestion in Malton but that the problem is worse in Norton. The traffic is being monitored by Trading Standards staff. Two local business have got exemption for their HGV vehicles to go over the crossing.
- The Ryedale Area Committee has now been amalgamated with Thirsk to enable the MP Kevin Hollinrake to attend. There will be at least one meeting per year in Ryedale.
- Ryedale House is due to be sold for development.
