## 110. Planning matters

15/05271/FUL: Brook House Farm Wotton Six Ashes Erection of a detached subterranean garage, single storey extension and porch insertion of roof lights and internal alterations. It was noted that no decision had been made by the Parish Council on this application and the Clerk had therefore indicated to Shropshire Council that the Council supported the application.

Shropshire Cllr. Tina Woodward confirmed that an amendment had been made to 15/03687/FUL (Brook House Farm land, Wootton, conversion of agricultural buildings to dwellings) including changing the number of proposed dwellings from 5 to 4. The planning authority had no requirement to consult the Parish Council again on the amended application but they would do so once other representations had been received.

The Clerk received an alert for a new application at Hampton Loade: 16/00245/FUL: 4 Waterworks Cottages Hampton Loade, erection of first floor extension to the side and porch extension and it was agreed that Cllr Roger Brown investigate the application further.

If he was satisfied with the application, the Planning Authority is informed that the Parish Council supports its approval.

## 111. Grants

It was resolved that the following grants applied for by St Andrews Church be approved:

- a) St Andrew's Church Roof repairs at a cost of £216.00 (subject to a formal application form being submitted)
- b) Grass cutting

£250.00 approved.

It was unclear whether the PCC were asking the Parish Council for assistance towards paying the Parish Share and that this matter is considered again if a formal request for assistance was received from the PCC.

## 112. Local Roads and Footpaths

It was noted that part of the A442 was to be closed at night for up to 3 weeks in March. Shropshire Highways would meet with Alveley and Quatt Malvern Parish Council to discuss further details of the precise times and dates of closure and of the proposed diversion routes.

# b) <u>Hampton Loade Car Park</u>

Cllr. R Brown reported that the National Trust were to have met with the Birmingham Anglers Association to discuss the proposal to close the car park at night to prevent illegal fishing. The outcome of the meeting was awaited. It was resolved that the Clerk request the Trust to update Cllr. Brown on the result of the meeting.

It was noted that the new register of electors was now available.
