# Minutes of a Planning Committee Meeting held on Monday 17<sup>th</sup> February 2020 at 7.30pm in the Committee Room, Speldhurst Village Hall

**MEMBERS PRESENT**: Cllrs Ellery (Chairman), Barrington-Johnson (ex-officio), Milner (ex-officio), Rowe and Turner

OFFICERS PRESENT: Mrs Kate Harman – Assistant Clerk

MEMBERS OF THE PUBLIC PRESENT: There was one member of the public present.

- 1. **Election of Chairman: RESOLVED** that Cllr Ellery be Chairman of the Planning Committee until May 2020.
- 2. **To enquire if anyone present intends to film, photograph and/or record the meeting:** no one present intended to film, photograph and/or record the meeting.
- 3. **To receive and approve apologies and reasons for absence**: apologies were received from Cllrs Scarbrough (holiday), Mrs Woodliffe (work commitments) and Mrs Price (holiday).
- 4. **Disclosures of Interests**: Cllrs Ellery and Rowe declared a pecuniary interest in application no. 19/03407/FULL for the Speldhurst Community Shop. Cllr Barrington-Johnson said he knows the applicant for application no. 20/00244/TPO this property belongs to a friend.
- 5. **Declarations of Lobbying**: there were none.
- 6. **Minutes: RESOLVED** that the minutes of the Planning Committee meeting held on **15**<sup>th</sup> **January 2019** be approved as a correct record and signed by the Chairman.

## 7. Matters Arising:

- The Old Dairy, Barden Road, Speldhurst The Assistant Clerk had contacted the Enforcement Officer regarding the tree trunks laying along the boundary of the development. She had been advised that KCC would investigate the matter with a view to getting them removed.
- Attendance of councillors at Planning meetings concern had been raised that there were sometimes insufficient councillors attending planning meetings which meant that the workload was being carried out by the same few councillors for each meeting. The Assistant Clerk said that ClIr Barrington- Johnson had agreed to attend future planning meetings; the new councillor would join the planning committee and additionally ClIr Mrs Price would be returning to the planning committee with effect from the March meeting. It was hoped that the combined effect of these measures would prevent future problems.

- Cedar House, Monteith Close, Langton Green the Assistant Clerk had written to TWBC Enforcement asking what the process was in getting the fence removed. She had chased but was awaiting a response.
- Furzefield Farm, Speldhurst the Assistant Clerk had written to the planning officer for this
  application however no response had been received. She would chase. The wider issue of the
  Assistant clerk not receiving planning notifications from TWBC was discussed and it was agreed
  she would speak to TWBC to get the issue resolved.
- 8. **Public Open Session:** Mr Edward Pinnell, Chairman of the Speldhurst Community Shop Steering Group attended the meeting. He explained that the original application had been approved however there were discrepancies between the plan and the works carried out which had been identified by Planning Enforcement. The Steering Group had submitted a new application which included changes to the fence at the side of the site; a minor change to the ramp to make it safer; relocation of the air-conditioning unit and a detailed planting scheme.
- 9. **Planning Appeals:** there were none.
- 10. Planning applications for discussion and decision:

## 19/03407/FULL

Location: Speldhurst Community Shop, Barden Road, Speldhurst, Royal Tunbridge Wells, Kent TN3 00D

Proposal: Erection of raised decking and terrace area at front of site to create an external customer seating area, creation of flat access adjacent to existing ramp, erection of timber fencing with trellis/timber balustrading with handrail (Retrospective).

It was noted that SPC had made a grant towards the Speldhurst Community Shop project.

Decision: We support this application.

## 20/00148/FULL

Location: 3 Knowle Close, Langton Green, Royal Tunbridge Wells, Kent TN3 0EP Proposal: Variation of Condition 2 of 19/00329/FULL (Demolition of existing dwelling and erection of 2 dwellings, access and parking) – Amendment to design to include insertion of

small dormer windows.

Decision: Remain neutral – leave to Planning Officer but we are concerned about the increase from four to five bedrooms in each property and any consequent impact on parking.

Location: 38 Farnham Lane, Langton Green, Royal Tunbridge Wells, KENT TN3 0DQ

Proposal: Erection of outbuilding including veranda (retrospective).

Decision: Remain neutral – leave to Planning Officer

#### 19/02218/FULL

Location: Priestfield Stables, Old House Lane, Fordcombe, Tunbridge Wells, Kent TN3 ORE Proposal: A retrospective application for the demolition of the existing stables building and the erection of a larger replacement stables building.

Decision: Remain neutral – leave to Planning Officer.

#### 19/03331/LAWPRO

Location: Langton Green Recreation Ground, Speldhurst Road, Langton Green, Tunbridge

Wells, Kent TN3 0JJ

Proposal: Lawful Development Certificate (Proposed) – Lay rubber matter on peripheral

section of recreation ground adjoining the car park, for overflow parking.

Decision: We strongly support this application. Please note SPC is the applicant.

## 20/00078/FULL

Location: South Acre, Southfields, Speldhurst, Tunbridge Wells, Kent TN3 OPD

Proposal: Demolition of conservatory and erection of two storey rear extension; erection

of detached double bay garage; complete refurbishment.

No planning notice spotted.

Decision: Remain neutral – leave to Planning Officer.

## 20/00076/FULL

Location: 2 Cleveland Cottages, Barden Road, Speldhurst, Tunbridge Wells, Kent TN3 OPX Proposal: Relocated opening to the single storey rear projection with additional rooflight above; addition of a rear dormer roof extension, altered opening to the north west side elevation and, 2 no. rooflights to the front roof slope.

Decision: Remain neutral – leave to Planning Officer.

## 20/00318/TPO

Location: Ashdown, Monteith Close, Langton Green, Royal Tunbridge Wells, Kent TN3 0AD Proposal: Trees: Early Mature Oak (T1) – Minor crown lift of 2 no. low limbs, further 2 no. limbs to be removed on opposite west side of stem, limbs pruned back to stem, target prune tips of two higher limbs on neighbours side (approximately 2.5m reduction); Early Mature Oak (T3) – De-limb 1 low branch.

Decision: Remain neutral – leave to Tree Officer.

#### 20/00244/TPO

Location: 10 Hither Chantlers, Langton Green, Tunbridge Wells, Kent TN3 0BJ Proposal: Trees: Oak (T8 & T9) – Hort link pruning 212, 70% crown reduction with

biennial pruning management.

Decision: Remain neutral – leave to Tree Officer.

#### 20/00282/TCA

Location: April Cottage, 4 Penshurst Road, Speldhurst, Tunbridge Wells, Kent TN3 OPB Proposal: Trees in a Conservation Area Notification: Apple Tree (T1) – Fell and remove root, replace by small specimen tree.

Decision: Remain neutral – leave to Tree Officer however we don't understand what a 'small specimen tree' means.

## 20/00277/TCA

Location: Larkhill, Langton Road, Speldhurst, Royal Tunbridge Wells, Kent TN3 ONP

Proposal: T1 (Cherry) - Fell.

Decision: Remain neutral – leave to Tree Officer. We have a strong point of view that if a tree is removed, it should be replaced with a suitable tree.

- 11. **TWBC Draft Local Plan:** The draft local plan document had been received from TWBC and circulated to councillors. It showed all the responses from members of the public to the consultation which were noted. Cllr Ellery gave a summary of the chief concerns which included:
  - the environment;
  - school parking and the safety of children;
  - lack of adequate infrastructure;
  - traffic and in particular speeding and the siting of the access road on such a dangerous bend; and
  - whether there would be adequate car parking spaces provided in the new development and the likely overflow onto surrounding roads.

Councillors agreed that a traffic management plan was a priority. It was agreed that a recommendation would be made to Full Council for all councillors to view the comments online so that they were aware of residents' concerns for when the plan is addressed again in the next round of consultation.
