Minutes of the Parish Council Meeting held 4th September 2023

1. Open Forum – Mrs Kibble-White said she had picked up several gas cylinders which it is believed for drug purposes but wondered how she could get rid of them. She said she had contacted the Police but they weren't interested the District Cllr said she would speak to someone at the Council and would report back to Parish Council.
