Matters raised included the successful Halloween evening; councillor contact details on the website not all correct; street lights in the old library car park on 24 hours; an enquiry whether a Healthy Living Centre would ever be built in Brandon; trimming of the churchyard trees overhanging the sheltered housing complex; thank you to the Carnival Committee for the High Street flags; concerns that the trees in the churchyard are not to be trimmed on a three year cycle (as advised by the Tree Officer); three streetlights in George Street car park not working; update on the insurance claim for the two trees demolished by a traffic accident.

4. MATTERS ARISING for information exchange only of the Brandon Town Council Meeting of Monday 2 November 2015. In relation to agenda item 11, Cllr. T Simmons asked those councillors who left the room without the Chairman's permission to justify their actions. In response, councillors felt the proposition put forward 'not to accept financial liability for the work carried out to a tree on private property in Victoria Avenue' was illegal and consequently felt they did not want to take part in the vote. Other matters raised included the non-working street lights in George Street car park and outside The Flintknappers, the street lights in the old library car park on 24 hours (all reported); concerns that with the meetings now recorded, any discussions during the confidential section of the meeting could be compromised (the recorder will be locked in the safe and the transcript deleted following the approval of the minutes); grit delivery and bins (imminent); update on the Anglo Saxon information board at the BRPF (DB to action); the two trees demolished by a car on London Road (due to lack of response by the driver of the vehicle, a claim has been

submitted to the Small Claims Court). A question was asked whether the town council were in fact responsible for these particular trees as they abutted the Highway (to be investigated); the reason why the Brandon Flint Murals are currently being housed at the Ancient House Museum (only on loan whilst the Heritage Centre is shut for the winter period).

Agenda item 6 was now heard:

# 6. TO RECEIVE A REPORT FROM RAF LAKENHEATH

Squadron Leader Neilds said Gate 1 will be closed this weekend; a security breach at Gate 8 was a false alarm but did result in the A1065 being closed for a while. Apologies were given for the inconvenience.

#### 5. PUBLIC FORUM

Matters raised included the very muddy bridleway at the junction of Small Fen Lane / Chalk Road and the environmental issue of oil in puddles at the same location (land owner to be contacted); a thank you to the Town Clerk and her assistant for ensuring the success of the Christmas Fayre (costs for the fireworks were met by donations); compliments on both the Cemetery and Victoria Avenue; horticultural work to the cemetery trees (Tree Officer to provide a written report). Other issues raised included the inability to access the Brandon website (LCPAS to be contacted); the town clock timing problem (a pendulum regulator to be purchased from Cllr. Silvester's locality budget); discussions relating to the relocation of the Heritage Centre (no decisions have yet been made by the Trustees); blocked drains and soakaways in Brandon (for the most part rectified); completion of general horticultural work to the trees in Victoria Avenue (VL); a request to see the audit paperwork for the Brandon Remembrance Playing Fields end of year accounts (VL).

# 7. TO RECEIVE REPORTS FROM COUNTY AND DISTRICT COUNCILLORS

Cllr. R Silvester reported he had attended a Graduation Ceremony at IES Breckland School with over thirty pupils going on to higher education. Furthermore, a donation from Cllr. Silvester's locality budget of £1000 is to be given to the school towards the Duke of Edinburgh Award Scheme. Cllr. P Ridgwell said he felt Brandon was lacking facilities for holding private functions and considered a village hall to be a necessity. It was pointed out by members, the Leisure Centre, Royal British Legion, Brandon Social Club were all suitable and available for holding all types of events. Due to the Government subsidy being scrapped in the next financial year, a £40 brown bin tax will be imposed by Forest Heath District Council on residents wishing to keep their brown bins. Cllr. Ridgwell said he had voted against the proposal.

Cllr. P Macloughlin left the meeting at 7.55pm.

#### 8. URGENT BUSINESS

Two matters of urgent business were raised by the Chairman:

a) The Christmas lights on Market Hill and along the High Street were once again an impressive feature of the town b) The Brandon Poors Estate needed one additional Trustee. Cllr. G Hughes agreed to fill the position.
