# Minutes of the electronic Meeting of the Parish Council held on Wednesday 3rd February 2021 at 7.30pm

210201 To receive Apologies for Absence and Declarations of Interest

All Councillors present. Also in attendance Cllr Bruce Laughton and Cllr Sylvia Michael

210202 To accept the minutes of the meeting held on 6<sup>th</sup> January 2021 Accepted. Proposer – Councillor P. Laughton, Seconder – Councillor G Francis.

- 210203 To note and report matters arising from the minutes not covered elsewhere on the agenda
  - i) Parish Clock update
    - The Clerk read an email received from the Weston PCC which stated that application was being reviewed by DAC on 8<sup>th</sup> February, followed by 30 day public notice period
  - ii) Update about concerns about motorbikes travelling at speed on Great North Road The Clerk confirmed that she had emailed the Beat Officer and was awaiting a reply
  - iii) Update on Rural Broadband Scheme

Councillor G Francis confirmed that he had spoken to the Notts CC Broadband Liaison Officer who was very helpful and gave a step-by-step guide to investigating the Scheme. The Village addresses have been put in the Open Reach website. OR then come up with the cost based on the number of addresses. Waiting for response from OR. Council Matching Scheme expires in March. Need figures from OR, and can then canvas villagers, who apply for vouchers.

210204 To receive reports from County Council and District Council Representatives

Cllr Michael reported that there had been an increase in noise complaints

during the pandemic.

Cllr Michael reported that with regard to the Cattle Market in Newark the issue is wanting someone to come forward to take it on. The lease came up for renewal and was advertised. The Council want it run for 2 years on the current site and for it then to move up to the Showground, together with the Lorry Park. No-one is coming forward to take it up on that basis.

Cllr. D. Chase, said that local farmers were concerned. The Clerk is to draft an email to NSDC stating that a resolution is needed to the situation concerning the Cattle Market at the current site

Cllr Michael reported the following re: vaccination programme:

As of 28th January, there are 3 Hospital Hubs, and 10 local vaccination sites within Notts administering the vaccine. As of 28th Jan, 37,140 over 80s have had the vaccine (74.6%) in Notts. In total 84,336 vaccines have been administered to the top four priority groups across the county. Letters have gone out to the over 70s, and the clinically extremely vulnerable inviting them for an appointment.

CIIr B Laughton reported that a few people are having to travel a distance for their COVID vaccine, but this is due to pressure of numbers.

He also reported that a traffic regulation order was going out for double

yellow lines on the right-hand side of the Cromwell Slip Road where lorries park.

It was noted that more potholes were opening up due to the cold weather. There is a patching programme in progress, but there have been lots of complaints.
