23-057 To receive an update and discuss matters arising regarding Claybrooke Joint Burial Board

- The UPC Burial Board representative advised UPC that there has not been a meeting of the Burial Board since early November 2022.
- It was noted that Cllr. Smith and the UPC Clerk attended a second cemetery training course on 14.03.23.
- It was agreed unanimously that now there are Joint Burial Board representatives appointed for Claybrooke Magna and Claybrooke Parva, Cllr. Smith can resume his appointment as the Joint Burial Board representative for UPC.

23-058 To receive an update and discuss matters arising at Ullesthorpe Playing Fields Association

The AGM took place on 9th March 2023 and have held their inaugural meeting. There are now enough representatives to be Trustees and the governance documents are being reviewed.

23-059 To receive an update and discuss matters arising at the railway cutting

- Planning permission has been granted for the tree works.
- The archway installation was not completed due to the weather, the contractor now thinks they will need lifting equipment to complete the works.
- Cllr. Mooney proposed that a quote is obtained for the repair of the sleepers and fence that have fallen onto the pathway, Cllr. Smith seconded the proposal. The Parish Council will only get one quote as the work required is urgent.
- The Clerk will ask Peter Leadbetter for an update on the progress with the bench.
- UPC will contact the three tree surgeons who previously quoted for updated quotes for treeworks.

23-060 To receive an update and discuss matters arising regarding village maintenance

- The poor condition of the road surface on Mere Lane has been reported to Leicestershire County
- It was noted that the litter bin near the bus stop has been covered to prevent use, presumably by Harborough District Council, Cllr. Page will try to find out why this action has been taken.
- A parishioner has reported the poor condition of the playground equipment at the playing field, UPC will raise the matter with the Playing Field Association.
- UPC will continue with the application to Leicestershire County Council to site the Platinum Jubilee Commemorative Bench opposite the shop, no suitable alternative location can be identified.

23-062 To receive an update on the forthcoming elections

The Parish Council election is scheduled for 4th May 2023. Nomination papers need to be submitted to Harborough District Council by 4.00pm on 4th April 2023. If there are more than six candidates for Ullesthorpe the election will go ahead.

23-063 To receive an update on celebrations for the King's Coronation

Cllr. Coombes, with volunteers, is organising a series of event to celebrate the King's Coronation. An application is to be submitted to the Harborough District Council Coronation Grant Fund for £500.00. If the grant is unsuccessful, Cllr. Smith proposed a £500.00 budget from UPC for the events, Cllr. Kavanagh seconded the proposal, all agreed unanimously.
