11. **BUS SHELTER:** Cllr Bailes has been out on site. The bus shelter will be made from metal and will be see through. He has been given 2 costings, whatever Cllr Baines contributes, will need to be match funded by Parish Council. The cost of putting it in by Ringway would be quite high. Cllr Orr-Cooper suggested that the Councillors build the bus shelters and had sent details of a 12' x 12' car port, 8"x 8" legs, timber frame, metal roof for £2500 offered by a local parishioner. Cllr Whittaker asked about maintenance of the Parish Council's existing shelter. He was advised that about £25 for creosote and £15 for plywood had been paid for in 21 or 22 years. However, Cllr Bailes advised that the liability aspect of the bus shelter needed to be considered.

Cllr Denyer would like 2 bus shelters, 1 each side of the road. Will revisit when costs have been received. Cllr Wheeler- Vine thanked Cllr Baines for being proactive with this. Cllr Whittaker to get price from District Council depot, Cllr Baines isn't sure if his grant can be used in this instance.
