# KIRKLINTON PARISH COUNCIL

Minutes of a meeting of Kirklinton Parish Council held on Wednesday 14 December 2022.

**MINUTES** of the Meeting held on 20 September 2022 were approved as a correct record and duly signed by the Chairperson.

## **MATTERS ARISING**

(a) Play area - Monthly inspections

Monthly Inspection Report forms were distributed to those Members next on the rota as follows:.

(b Play area – top up play surface

As the winter months had now set in it was agreed that the matter of 'topping up' the bark surface should be considered at the next meeting in February 2023.

(c) Play area – maintenance for 2023

It was agreed that Green Team Garden Services, a local Carlisle based grounds and garden maintenance business and the person suggested by Mrs M Story should both be approached to undertake the work at the appropriate time.

# (d) Defibrillator at Fir Ends School

The Clerk reported that he had received no further communication from the school regarding either the repairs which the Parish Council had agreed to fund, or the issue of a more appropriate location for the unit.

#### **INCOME AND EXPENDITURE 2022/23**

The current income and expenditure as compared against the approved budget as at 29 November 2022 was noted.

A request from the GNAAS for a donation was noted.

#### **BUDGET AND PARISH PRECEPT 2023/24**

The Clerk presented a draft budget for 2023/24 which itemised proposed expenditure amounting to £2,850.00 and an income projection of £2,651.00. Balances as at 31 March 2024 were projected to be £3,791.00. Following a discussion it was agreed that:

- (1) The Budget for 2023/24, as presented, be approved;
- (2) Grant Applications re any proposed Capital projects be submitted as required;
- (3) A Parish Precept of £2650.00 for 2023/24 be approved and submitted to Carlisle City Council.

## PLANNING APPLICATIONS

## (a) Application No. 22/0388 (Julian Berry)

Replacement roof to existing domestic outbuilding/workshop with double pitched slated roof and addition of 2No. velux roof lights; rebuilding of front and internal walls of workshop at Humphries House, Scaleby, Carlisle.

The decision of the Planning Authority to grant permission for this development was noted.

## (b) Application No. 22/0648

Conversion of agricultural building to form 1No. dwelling together with erection of detached garage and demolition of dilapidated former agricultural buildings at Barn aat Willow Hill Farm, Smithfield, Kirklinton, Carlisle.

The decision of the Planning Authority to grant permission for this development was noted.

# (c) Application No. 22/0703 (Palmer)

Change of use of existing annexe, tower and carriage shed to provide 3No. holiday units. Minor alterations to two existing external doors. Formation of three internal doors and openings to carriage shed. Installation of mezzanine floor, staircase. Installation of shower/WC to tower rooms and carriage shed at Kirklinton Hall, Kirklinton, Carlisle.

The decision of the Planning Authority to grant permission for this development was noted.

## (d) Application No. 22/0704 (Palmer)

Change of use of existing annexe, tower and carriage shed to provide 3No. holiday units. Minor alterations to two existing external doors. Formation of three internal doors and openings to carriage shed. Installation of mezzanine floor, staircase. Installation of shower/WC to tower rooms and carriage shed (LBC) at Kirklinton Hall, Kirklinton, Carlisle.

## (e) Application No. 22/0800 (Mrs J Forbes)

Change of use from residential to holiday let accommodation at Angerton Cottage, Blackford, Carlisle.

## (f) Application No. 22/0819 (Mr K Little)

Erection of detached garden store at Farwood Lodge, Fergus Hill, Kirklinton Carlisle.

The observations of the Parish Council and the decision of the Planning Authority to grant permission for this development were noted.

## (g) Application No: 22/0834 (Mr C Carr)

Erection of 1No. dwelling and associated access (Outline) on land adjacent to 8 Skitby Road. Smithfield. Carlisle.

## DOG FOULING ON THE ROAD FROM A6071 TO HETHERSIDE

Mr Allan reported that he had contacted Carlisle City Council (Environmental Department) regarding dog fouling on this especially on the corner adjacent to the Poultry Unit. Some appropriate road signs – No Parking and No Dog Fouling- had been suggested but required a suitable post to fix them on which was a Highways responsibility.

The Clerk was asked to write to the County Council Highways Department with a view to them erecting a suitable post.
