Bank card scam - a local resident had a telephone caller claiming to be from Lloyds Bank in Andover, needing to exchange her bank card. This resulted in a man visiting the resident's home, swopping the card and taking the pin number resulting in a considerable sum of money being taken from the account. No bank would ever act in this way – if it sounds wrong, then assume it is and hang up and report it to your bank and Action Fraud https://actionfraud.police.uk/.

There has also been an increase in **fake Netflix emails** and **fake TV licensing emails**. Clicking on the link in these emails will result in your details being stolen. Never automatically click on a link in an unexpected email or text.

Please also be aware that reports have been received of **rogue traders** in the area looking for tree work and similar. **Not sure? Don't open the Door!**

Scamnesty Campaign

Police & Crime Commissioner Michael Lane has launched a Scamnesty campaign to encourage people to report scams and to offer advice on how to avoid becoming a victim of fraud. Hampshire Constabulary receives over 700 reports of fraud or attempted fraud each month, many of these targeting the elderly or vulnerable and the consequences can be extremely damaging both financially and emotionally for the victims. Did you know

All police forces have ceased to accept lost property reports as of 1st October 2018. Hampshire Constabulary will no longer accept reports of items that have been lost or found in a public place. <u>Visit their website to report lost property</u> where you will find a Lost Property Insurance Notice to give to your insurers.

There are a few exceptions - officers receiving phones will try to trace the owners, while any bank cards handed over will be destroyed in order to prevent them being used fraudulently. Missing bank cards should be reported to the appropriate bank and a lost mobile phone should be reported to the service provider. Lost foreign identity documents must still be reported in person at a police enquiry desk, but anyone who has lost a British identity card or British passport must instead report it to the Passport Office. The DVLA (Driver and Vehicle Licensing Agency) must be notified about lost driving licenses. Forces will still accept items that may be linked to a crime, alongside firearms, weapons and ammunition, passports, drugs, pornography and items where the owner is identifiable.
