The Chairman welcomed Sgt. Keith Grant and Sgt. Liam Garrard to the meeting. Safer Neighbourhood Team report: Over the last month there has been a reduction in both criminal damage and thefts from motor vehicles. The SNT Environmental Impact Day held on the 21 March 2007 at Brandon and Mildenhall proved very successful. Preliminary

statistics for the day were encouraging. In relation to the removal of the planters, there is to be a street briefing on the Market Hill on Saturday 7 April at 11.00 am. Councillors are invited to attend. A further street briefing at Thetford Road has been organised for the 28 April 2007, again at 11.00 am. Issues to be addressed include traffic calming and the reinstatement of the bench at the play area. With regard to a drinking ban on Market Hill, further investigation is needed to be carried out before a byelaw can be initiated. The Police will offer assistance if required.

Sgt. Grant informed Members this was his last Town Council meeting as he will be leaving Brandon on the 10 April to take up a post in Newmarket. Sgt. Liam Garrard will be his replacement. Cllr. R Silvester thanked Sgt. Grant for his work within Brandon and wished him every success in his new role.

Questions to Sgt. Grant included the increased number of cars parking on Market Hill, youths congregating on the bench sited at Church Road and the reduction of police officers for Brandon. In response, Sgt. Grant said these issues are currently being addressed by the SNT.
