The Minutes of the Meeting held on the 29th March 2016 were agreed by the Town Council and signed by the Chairman as a correct record subject to the following addition.

108/15 Chairman's Items:

The Chairman reported that he and the Vice-Chairman will be meeting with representatives of Shropshire Council to discuss partnership working in relation to local services and would report back to a future meeting. The Chairman reported that a bonfire had been lit to celebrate the Queens 90th Birthday celebrations.

109/15 Highway Items:

The Clerk reported on discussions held with the South Shropshire Housing Association concerning the solar powered street light behind 43 Shrewsbury Road Craven Arms.

The Housing Association agreed that they would meet 50% of the cost of converting the light to a conventional electrical powered street light the cost of which be $\pounds 1,095.52$ plus VAT this including the replacement lighting equipment and the electrical supply.

It was proposed by Cllr D Evans seconded by Cllr C Leworthy and agreed by the Town Council to place an order with Eon for the conversion of the light at a cost of $\pounds1,095.52$ plus Vat with 50% of the cost recoverable from the South Shropshire Housing Association.

110/15 Amenity Items:

a) Craven Playing Fields:

The Clerk reported that a second football pitch could be provided on the playing fields however it would only be at the minimum size required by the Football Association, however appropriate netting etc. could have to be erected to help prevent the balls going in neighbouring gardens. The Pitch would need to be shared between the proposed Sunday Football Team and the Junior Football Teams.

The Clerk awaiting confirmation that a Sunday Team will be proceeded with and that they had an appropriate Committee and financial structure in place.

b) Agreement between the former British Railways Board and the former Stokesay Parish Council dated 1st April 1987.:

The Clerk was still awaiting details of the safety work that was required in respect of the trees that border the railway which are the responsibility of the Town Council.

c) Bus Shelter - Harry Tuffins:

The Clerk was still trying to arrange a meeting with Harry Tuffins to discuss the replacement of the Bus Shelter which was previously on the car park area of the supermarket. The Clerk would also approach highways about the possible positioning of a new Bus Shelter.

d) Everybody Active for Every Day Grant Scheme:

Cllr M Trafford referred to the Everybody Active for Every Day Grant Scheme where £30,000 was available for the Craven Arms Area for new initiatives and suggested that the Town Council should consider submitting a scheme. It was suggested that "Clean the Street" may be a possible scheme.
