Cllr M Ing/ S Pashley to put protection on the playground equipment once installed to protect against strimmer damage.

Cllr S Pashley has received a response from the Police Commissioner in relation to the geographical reporting of crime and the impact to the village. Cllr S Pashley to respond accordingly.

Following review of the verge damage, clerk to progress a complaint to NCC asking them to pursue remedial action.
