Apologies for Absence

1) Apologies had been received from TVBC Cllr Johnston.

Election of Chairman

2) Cllr Elliott nominated Cllr James to be Chairman for the forthcoming year. This was seconded by Cllr Keane. All Agreed. Cllr James signed an acceptance of office form.

Election of Vice Chairman

3) Cllr James nominated Cllr Elliott and Cllr Hodgson as joint Vice Chairmen for the forthcoming year. This was seconded by Cllr Boulton. All Agreed.Cllr Elliott and Cllr Hodgeson signed acceptance of office forms.

Review and agree Standing orders, financial regulations & Code of Conduct

4) All documents had been circulated to Councillors prior to the meeting. These were all based on NALC model documents and the Clerk confirmed no amendments had been published. Cllr James proposed all documents were re adopted for 2022-23. This was seconded by Cllr Elliott. All agreed.

All Councillors confirmed there were no revisions required to Register of Interest forms.

5) No members of public present were present.

TVBC Cllr Johnston was absent, however had circulated the latest Mid Test Matters.

Minutes

9) **Resolved**: The minutes of the meeting held on 5th April were confirmed as a correct record and were signed by the Chairman. Proposed Cllr Mann, seconded Cllr Dumper. All agreed.

Streetlight Queenwood Road

10) Cllr Keane reported the street light matter is still under review.

Housing Needs Survey & Neighbourhood Plan

11) Cllr James confirmed there will be a village meeting on 22nd June, 7.30pm at Broughton Village Hall when villagers will be asked to consider housing needs in the parish. Officers from TVBC will be present.

Sports Field Update

12) Cllr Elliott confirmed he had taken the concerns of the Parish Council expessed at the last meeting to the Sports Field Committee and was happy that the concerns were now being addressed.

Simon Henderson, Chairman of the Sports Field Committee apologised for delays in moving the new sports pavilion project forward. He said matters were now progressing and had recently sent The Clerk minutes of the last committee meeting. He said a lot of work has taken place with regard to tender documents and they are almost ready to ask building firms to provide quotes. Once received the costs of the build can be considered and further grants persued. He confirmed the required criteria of a committee to manage the whole of the Sports Field has almost been met. Discussions are taking place to appoint a remunerated secretary and a treasurer and all minutes will be sent to the Parish Council going forward. He said the football and the cricket club are now working together to move forward and while the largest part of discussions is about the new build other items are being considered such as joint insurance

Cllr James said at the current time because the full committee is not in place the Parish Council cannot make a firm promise to provide £150,000.00 toward the cost of the new build. While they fully support the project they need to be sure the criteria they set has been met. The Clerk confirmed the tender documents have been circulated recently to all Parish Councillors who agreed to review these by 9th May. Once any amendments required are made it was agreed the PC will instruct the agent Temple Ford to send out tender requests to four local building firms. In the mean time they look forward to receiving confirmation that a full Sports Field Committee is in place.

Renovation of vintage road signs

13) The Clerk confirmed she had contacted HCC highways regarding the vintage road signs and confirmed these signs were the resposnsibility of HCC however they have no plans to renovate these at present or remove and replace them as they are not considered dangerous. The Parish Council has the power to renovate these signs and pay for the works required however they must meet the guidelines of insurance, contractors and licences of HCC. If any S106 funds are held they can be used for projects such as these but Broughton Parish Council do not hold any funds as they were spent on the traffic calming initiatives. If the Parish Council use the HCC contractor who has provided a quote the cost will be £3200.00 in total. TVBC have given a grant of £1000 and HCC £400 however the Parish Council would need to meet the balance of £1800.00.

Cllr Hodgson suggested these signs were probaly installed at the time the Queen first came to reign and it would be a fitting tribute to her in the Platinum Jubilee year to have them renovated. Cllr James will suggest this to parishioners at the annual village meeting. If there is general agreement the Parish Council will move forward with the project and pay the additional sums to complete the work required.

School Lane Completion work

14) Cllr Boulton confirmed that no progress has been made with the ongoing issues. He said he was unable to get a response from the solicitor now acting. All Councillors expressed their dismay with the unacceptable delays and asked The Clerk to write to the Senior Partner expressing dissatisfaction and confirming an official complaint will be made if the situation continues. Finally, despite the continuing delays Cllr Boulton confirmed he is in the process of obtaining quotes for the installation of a MUGA.

Clerks Report

15) The Clerk reported as follows: -

The Clerk confirmed Cllr McAlister and Cllr Morrison have been booked on a new Councillor taining course in early June.

The Clerk confirmed Land Registry had acknowledged her application to register the Village Hall under adverse possession rules. The application was made in March 2021. The acknowledgement was dated April 2022!

The Clerk confirmed she has contacted TVBC rates department to establish why the Parish Council pay rates on the Cemetery from funds which are provided by them. A reply is awaited.

Footpaths.

16) Cllr Elliott has cut back some brambles on The Clarendon Way and noted some hedges that need to be cut back. The Clerk will write to the relevant householders.

Primary school place offers confirmed by Hampshire County Council

The County Council has processed more than 21,000 applications (21,288) for children to start school in reception year (Year R) and to move from infant to their first year of junior education (Year 3).

Just over 98 per cent (98.31 per cent) of parents have been offered a reception year place for their child in one of their three preferred choice schools, with more than 93 per cent (93.25 per cent) allocated a place at their first choice of school.

Children's food and activity scheme extended for three years

Hampshire County Council's Holiday Activities and Food (HAF) programme - which aims to help families facing hardship - is to be extended for another three years

Total funding worth approximately £10m will be allocated to the County Council by the Department for Education to continue running the scheme, which offers healthy food and enriching activities to eligible children during the school holidays – a time when some families struggle with the extra costs, such as food and childcare. In Hampshire, there are over 33,000 children who are potentially eligible for free HAF places.

Hampshire County Council statement on publication of gender pay gap information

The gender pay gap is a measure of the difference between men and women's average earnings across an organisation. For the year ending March 2021, on average, there is a 16% pay difference between men and women working at the County Council.

The majority of the workforce is female, and this is most pronounced at the lower pay grades. In particular, the County Council is quite unusual as a local authority, as it has kept a number of services in its direct control, such as school meals, because the County Council feels it is important to do so. Other agencies 'outsource' these services, which tend to employ mostly women, and that affects the gender pay gap reports. If these services were excluded from the data, the County Council would have a gender pay gap of 10.4%.

At the same time, more women are progressing to higher grade jobs with women continuing to make up 57% of senior managers within the organisation.

Young people highlight their key priorities in annual 'Make Your Mark' consultation

Young people across Hampshire voted environmental issues as their top concern in this year's 'Make Your Mark' consultation. Hampshire ranked second in the UK for participation in the consultation, with 17,385 votes cast in total

Young people (aged 11-18) in Hampshire were able to vote on a number of topics through the Hampshire Youth Parliament network and, for the second year running, placed 'Environment' at the top of their priorities with 4,260 votes. Jobs, money, homes and opportunities came in second place with 3,532 votes and health and wellbeing followed closely behind with 3,457 votes. This aligns to the national picture, which saw health and wellbeing and jobs, money, homes and opportunities voted in first and second place respectively.
